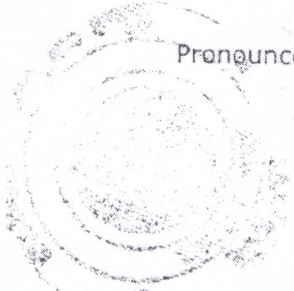

This case is coming before me for final hearing on 14.03.2014 in the presence of T.V.Govinda Rao, Advocate for Complainant and P.R.Laxmi, Advocate for Accused, and upon perusal of the oral and documentary evidence on record and having stood over for consideration, this court delivered the following:

JUDGMENT

A1 and A2 absent. Smt.P.R.Laxmi filed a memo of appearance for A1 and A2. She also filed two petitions Cri.M.P.No.639/2014 and Cri.M.P.No.640/2014 are allowed. Special Vakalat holder Jithender Singh is permitted to represent A1 and A2. Special Vakalat holder is present and he is examined U/Sec. 251 Cr.P.C. Special Vakalat holder admitted the offence on behalf of A1 and A2 and pleaded guilty for the offence U/Sec. 11(1) r/w rule 33 of B.I.S. Act. Hence A1 and A2 are found guilty. A1 and A2 are convicted U/Sec. 252 Cr.P.C. and sentenced to pay a fine of Rs. 10,000/- (Rupees Ten Thousand only) each in default to suffer S.I. for one month. Special vakalat holder is permitted to pay the fine amount on behalf of A1 and A2.
