ORDER

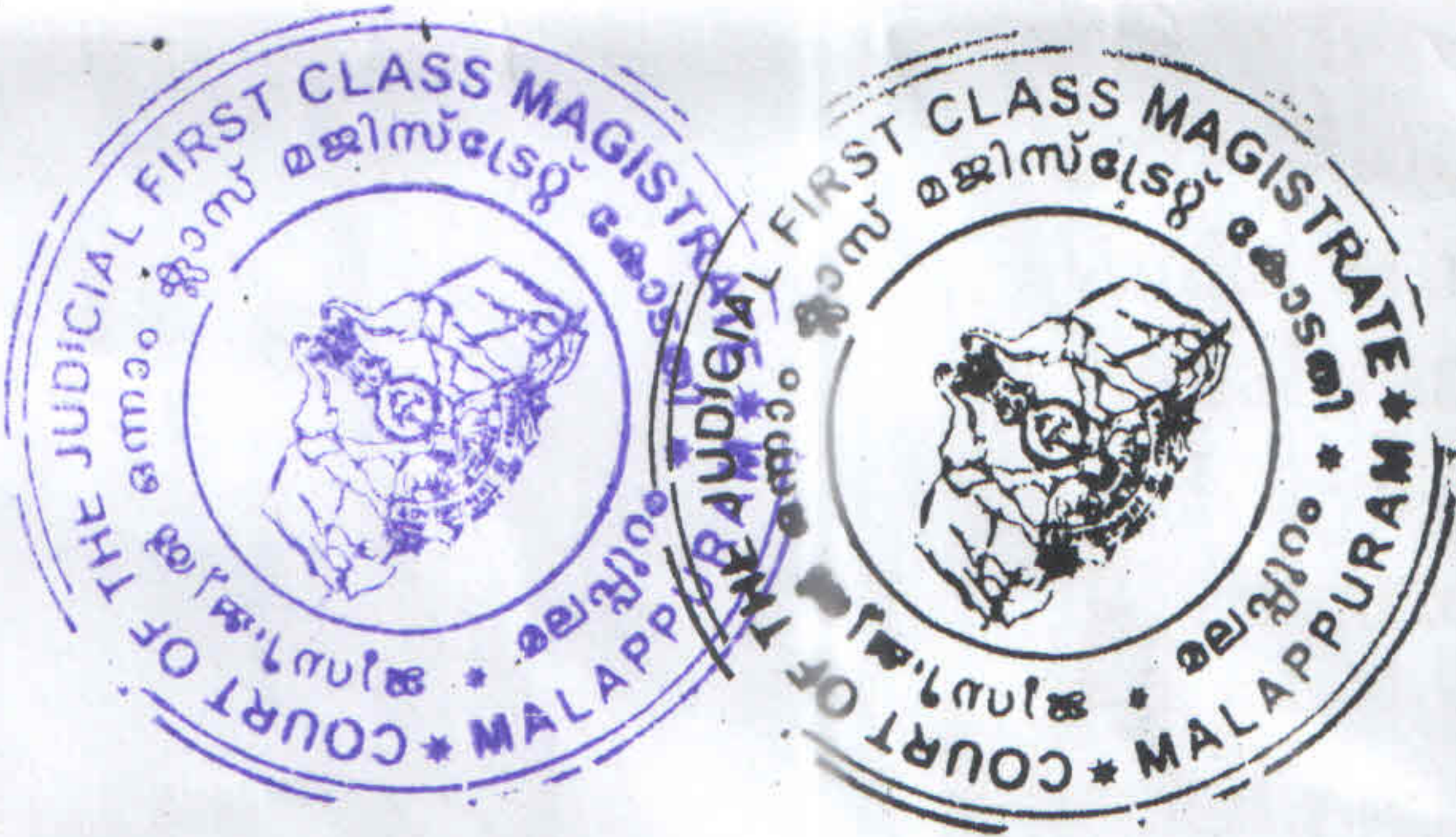
This is a Private Complaint filed by the complainant against the
