This is with reference to the enforcement cases pertaining to M/s Dhanalakshmi Polymers (Fan Division) and M/s Hero Kitchen Appliances and who have been found misuse of BIS Standard Mark during the enforcement search & seizure carried out on 20/07/2016 & 22/10/2016 and HYBO has filed the above said cases under STC No.28/2016 & 29/2016 respectively in the 6<sup>th</sup> Metropolitan Magistrate Court, Cyberabad, Medchal, Ranga Reddy District, T.S.

The Hon'ble Court has passed the judgement in both the cases in favour of BIS and penalized Rs 80,000/= and Rs 1,50,000/= respectively with a direction to forfeiture of the seized material to BIS. The copies of the judgement received in both the cases are enclosed for ready reference and further advice for disposal of the forfeited material. In view of the passing of the orders by the Hon'ble Judge, Sc-G & DDGS may kindly advise for:

- Further course of action to be taken with respect to the manner in which the forfeited material to be handled and disposal.
- Whether both the firms M/s Dhanalakshmi Polymers (Fan Division) and M/s Hero Kitchen Appliances wish to apply for BIS Certification Marks Licence, the applicable cooling period for entertaining their applications for considering GOLs.

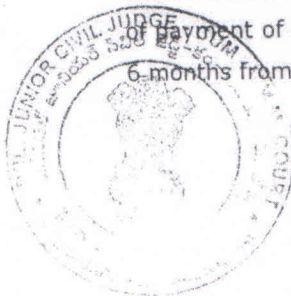

**ORDER**

Accused No. 1&2 are called present. They are examined U/s. 251 of Cr. P. C they are pleaded guilty take the lenient view. Considering the same by taking the lenient view and voluntarily pleaded guilty by the Accused No. 1&2 for the offence U/S. 11(1) R/w 33 of the Bureau of Indian Standards Act, non-renewal of licence directed to the Accused No. 1&2 are to pay the fine amount of Rs. 40,000/- each for the offence U/s 11(1) R/w 33 of the Bureau of Indian Standards Act, in default of payment of fine amount. They shall undergo simple imprisonment for a period of 6 months from the date of this order.

Further directed to the complainant i.e., Bureau of Indian Standards shall destroy the seized property i.e., Sl. No. 1 to 5 which are mentioned in the seizure report shall forfeit the same to Bureau of Indian Standards. Further directed to the B.I.S shall submit the distruction panchanama report before this Honourable Court with in one month from the date of this orders.
