Offence punishable u/s 11 r/w 33 and 34(1) of the Bureau of Indian Standards Act

Guilty

Guilty

Accused are found guilty of the offence punishable u/s 11 r/w 33 of the BIS Act and convicted thereunder. A2 to A4 are sentenced to pay fine of ₹25,000/- each. In default of payment of fine they have to undergo simple imprisonment for 2 months for the offence u/s 11 r/w 33 of the Bureau of Indian Standards Act.

JUDGMENT

- 1. This is a complaint case filed u/s 190 Cr.PC alleging offence punishable u/s 11 r/w 33 and 34(1) of Bureau of Indian Standards Act.
- 2. Complainant's case in brief is as follows: Complainant is the Scientist C, Bureau of Indian Standards, Kochi who has been duly authorised to file the complaint. A1 is the establishment by name 'Palliyambalam Gold and Diamonds'. A2 is the proprietor, A3 is the Manager and A4 is the person who is the sales- in -charge of A1 firm. On the basis of a secret information, the complainant and team members conducted a search in the premises of the 1st accused on 17/05/2017, 2593.22 gms of spuriously BIS Hallmarked Gold Jewellary comprising 391 pieces were seized from the premises of A1. Thereby they have contravened section 11 of the BIS Act which is punishable u/s 33 of the Act.

Sub: - Judgment dated 24.06.2017 in C.C.No.930 of 2017 filed by Bureau of Indian Standards against M/s Palliyambalam gold & Diamonds & others before the Hon'ble Additional Chief Judicial Magistrate Court, Thiruvananthapuram–reg.

As informed, the above case was advanced by the Hon'ble Court and finally heard on 24.06.2017 and the accused Nos. 2 to 4 are sentenced to pay fine of Rs.25,000/- each. - 3. After a preliminary inquiry the court has taken cognizance of the offence punishable u/s 11 r/w 33 of the Bureau of Indian Standards Act taken as CC 930/2017. At is the establishment represented by A2. A2 to A4 entered appearance and filed CMP 3020/2017 for pleading guilty to the charge. Copies of all relevant records produced by the complainant were furnished to the accused. Particulars of offence u/s 11 r/w 33 of BIS Act read over and explained to accused to which they pleaded guilty. Court satisfied that the plea of guilty is voluntary in nature. Hence accepted the admission.
- 4. Heard the counsel for the complainant and accused.
- 5. In the result, accused are found guilty of the offence punishable u/s 11 r/w 33 of the BIS Act and convicted thereunder. I am satisfied that this is not a fit case to invoke the benevolent provisions of Probation of Offenders Act. Considering the nature and surrounding circumstances, I am inclined to show some amount of leniency to the accused. Hence, A2 to A4 are sentenced to pay fine of ₹25,000/- each. In default of payment of fine they have to undergo simple imprisonment for 2 months for the offence u/s 11 r/w 33 of the Bureau of Indian Standards Act. Since they are first time offenders court ordered to return the properties to the establishment.
