### बीआईएस द्वारा नकली आईएसआई मार्क पैकेज ड्रिंकिंग वाटर की जब्ती

भारतीय मानकों का ब्यूरो भारत की राष्ट्रीय मानक निकाय है जिसे बीआईएस अधिनियम, 1 9 86 के अधीन मानकीकरण, अंकन और माल की गुणवता प्रमाणन की गतिविधियों के सामंजस्यपूर्ण विकास के लिए और इसके साथ जुड़े मामलों के साथ या इसके प्रासंगिक मामलों के लिए स्थापित किया गया है। आईएसआई मानक मार्क की लोकप्रियता में वृदधि के साथ, दुरुपयोग के उदाहरण भी आते रहे हैं।

भारतीय मानक ब्यूरो (बीआईएस), जमशेदपुर शाखा कार्यालय को एक विश्वसनीय जानकारी मिली कि रांची में पैकेज किए गए पेयजत के निर्माताओं में से एक बीआईएस मानक का उपयोग अपने उत्पाद पर बिना वैध उत्पाद प्रमाणन लाइसेंस प्राप्त किए कर रहा है और बाजार में बेच रहा है।

भारतीय मानक ब्यूरो (बीआईएंस) जमशेदपुर शाखा कार्यालय के अधिकारियों की एक टीम ने 18 अगस्त 2017 को मैसर्स मधुर जल, कोचबोंग, नामकूम, रांची, झारखंड में पुलिस की सहायता से एक प्रवर्तन खोज और जब्ती का संचालन आईएसआई मार्क के दुरुपयोग की जांच के लिए किया । पैकेज किए गए पेयजल पर आईएसआई मार्क के खोज अभियान के दौरान, मैसर्स मध्र जल, कोचबोंग, नमकूम, रांची, झारखंड के परिसर में आईएसआई चिहन के साथ पैक किए गए पेयजल पर्याप्त मात्रा में जब्त किये गए।

उपरोक्त इकाई के पास पैक किए गए पेयजल पर आईएसआई चिहन का उपयोग करने के लिए वैध बीआईएस लाइसेंस नहीं था। बीआईएस अधिनियम, 1 9 86 की धारा 11 के उल्लंघन के लिए बीआईएस एक्ट 1986 की धारा 33 के तहत अपराधी को दंडित करने के लिए कानून का न्यायिक न्यायालय में एक आपराधिक मामला दायर किया जाएगा।इस अपराध के लिए बीआईएस अधिनियम, 1 9 86 के अनुसार एक वर्ष तक कारावास या रु० 50,000 / - तक का जुर्माना या दोनों हो सकता है।

यह कई बार देखा गया है कि नकली आईएसआई चिहिनत उत्पादों का निर्माण किया जाता है और आम उपभोक्ताओं को बेच दिया जाता है। इसलिए, लोगों को बीआईएस वेबसाइट http://www.bis.gov.in पर जाकर खरीद से पहले उत्पाद पर आईएसआई मार्क की वास्तविकता का पता लगाना चाहिए।

इसलिए सामान्य जनता से अन्रोध किया जाता है कि यदि वे आईएसआई मार्क के दुरुपयोग से संबन्धित जानकारी पाते है, तो इसकी सूचना प्रधान, जमशेदपुर शाखा कार्यालय, बीआईएस, एफ / 10-ए, नामदीह रोड, पीओ- बर्मामीन्स, जमशेदपुर - 831 007, झारखंड को दी जा सकती है। इस तरह की शिकायतों को ई-मेल दवारा पता jdbo@bis.gov.in या hjdbo@bis.gov.in पर भी किया जा सकता है। बीआईएस वेबसाइट पर ऑनलाइन शिकायत दर्ज करने का प्रावधान भी है। ऐसी जानकारी का स्रोत गोपनीय रखा जाएगा।

#### PRESS RELEASE

#### BIS Seized Fake ISI Marked Packaged Drinking Water

Bureau of Indian standards is the National Standards Body of India established under the BIS Act, 1986 for the harmonious development of the activities of standardization, marking and quality certification of goods and for matters connected therewith or incidental thereto. With the increase in the popularity of the ISI Standard Mark, the instances of misuse are also observed.

Bureau of Indian Standards (BIS), Jamshedpur Branch Office received a credible information that one of the manufacturers of Packaged Drinking Water in Ranchi is using BIS standard mark on the product and selling in the market without obtaining a valid product certification licence from BIS.

A team of Officials from Bureau of Indian Standards (BIS) Jamshedpur Branch office conducted an Enforcement Search and Seizure operation with the assistance of police at M/s Madhur Jal, Kochbong, Namkum, Ranchi, Jharkhand on 18 August 2017 to check the misuse of ISI Mark on Packaged Drinking Water. During the search operation, substantial quantities of Packaged drinking water with ISI mark was seized at the premises of M/s Madhur Jal, Kochbong, Namkum, Ranchi, Jharkhand.

The above unit was not having valid BIS Licence to use ISI mark on Packaged Drinking Water. A criminal case would be filed in the jurisdictional court of Law to punish the offender under section 33 of BIS Act 1986 for contravention of section 11 of BIS Act, 1986. The offence is punishable with imprisonment up to one year or a fine up to Rs.50,000/- or both as per BIS Act, 1986.

It has been observed many times that fake ISI marked products are manufactured and sold to common consumers. Therefore, people should ascertain the genuineness of ISI Mark on the product before purchase by visiting BIS Website <u>http://www.bis.gov.in.</u>

General public are, therefore, requested that in case they come across any instance of misuse of ISI Mark, the same may be informed to the Head, Jamshedpur Branch Office, BIS, F/10-A, Namdih Road, P.O. Burmamines, Jamshedpur – 831 007, Jharkhand. Such complaints can also be made by E-mail at the address jdbo@bis.gov.in or <u>hidbo@bis.gov.in</u>. There is also provision to register online complaint at BIS Website. The source of such information will be kept confidential.

Subject: Search under Bureau of Indian Standards Act, 1986.

As you might be aware, BUREAU OF INDIAN STANDARDS (BIS) is the National Standards Body set up under an Act of the Parliament for harmonious development of the activities of Standardization, marking and quality certification of the goods in the country. The Bureau took over the assets, liabilities and functions of the erstwhile Indian Standards Institution (ISI) w.e.f 1 April 1987. The status of the organization was enhanced by the Government with a view to provide more statutory powers for enabling the organization to carry out its functions effectively. The BIS operates a Certification Marks Scheme under which licences are granted to the manufacturers for use of ISI Mark on the products under specified conditions. Thus, through this scheme, BIS makes available the benefit of third party certification to the common consumer.

With the popularity of the ISI Mark, the instances of misuse of the mark are on the increase. To check such misuse, necessary prohibitory provisions have been made under Sec. 11, 12, 14 & 15 of BIS Act 1986. Also penalties for the misuse have been prescribed under Sec. 33 of the Act. Employees of the Bureau have been declared as public servants within the meaning of Sec. 21 of the Indian Penal Code. Also Inspecting officers of the Bureau, to be appointed by the Competent Authority, have been empowered to undertake search & seizure of any place, premises or vehicle where contravention of Sec. 11 & 12 are believed to have taken place (Sec. 25 & 26).

During our recent market drives, it has been observed that large numbers of manufacturers/dealers are resorting to misuse of ISI mark and there is an urgent need to check the same. Towards this objective, we seek your help in the process of carrying out search and seizure operation on 18.08.2017 (Friday) at a place in accordance with the provisions under the BIS Act, for collection of direct evidence to facilitate prosecution of the offenders.

It is requested that you may consider advising the police station under your jurisdiction to provide necessary help in the form of one SI/ASI and three constables for search and seizure operation by BIS Officials.

We shall be pleased to have your response.

#### 2. CONCLUSION

On the basis of the observations made during the complaint investigation conducted at the complainant end, following conclusions are derived:

- a) The complaint is genuine as the material under complaint was available with the complainant and the same is found spuriously ISI marked with a licence number which is currently under expired condition as per the status available in the BIS website.
- b) The material as offered by the complainant (47 nos. of spuriously ISI marked PDW filled in 250 ml scaled plastic cups) were packed in 2 carton boxes and coded as KOBO/BJG/20170804/CP/I (24 nos.) & KOBO/BJG/20170804/CP/2 (23 nos.) respectively and brought to KOBO as material evidences and a receipt of acknowledgement was given to the complainant. Photographs of the tags/stickers used on these samples drawn and the receipt of acknowledgement issued to the complainant are enclosed at ANNEX - D.

#### **3. RECOMMENDATIONS**

Based on the above observations, it is recommended that necessary actions may be taken up by JDBO so as to take further actions such as conduct of Enforcement raids at the premises of the ex - licensee M/s. Madhur Jal, Koch Bong, Namkum, Ranchi 834010 and also at M/s. Femic India Healthcare Pvt. Ltd., Ranchi (if required), to redress the complainant's grievances on the ex - licensee.
