## ANNEX-II TERMS & CONDITIONS

- 1. The quotations shall remain valid for a period of 30 days from the date of opening.
- 2. Original catalogues with relevant features should be supplied along with the quotations. Every page of quotations must be signed by the authorized signatory of the bidder along with their stamp.
- 3. The TV is to be guaranteed for trouble free performance for a <u>minimum period of one year after</u> commissioning. The defects, if any, during the warranty period are to be rectified free of charge by arranging free replacement wherever necessary.
- 4. The Tenderer is required to furnish the Permanent Account Number (PAN)/TIN of the firm Allotted by the Income Tax Department.
- 5. Each quotation shall accompany EMD amount of Rs 6000/-. Which would be refundable after successful installation of TVs.
- 6. Payment condition: 100 % payment after successful installation of TVs.
- 7. Place of Delivery: The TV shall be delivered at our Lab:

- 8. Quotations/bids qualified by indefinite expressions such as "Subject to immediate acceptance" etc. and incomplete quotations are liable to be summarily rejected.
- 9. All goods shall be inspected by BIS preferably in the presence of supplier or his authorized representative, when the packages are opened for installation. The decision of BIS shall be binding. Rejected items/goods/stores shall be removed by the supplier at his own cost and risk, within 30 days of receipt of notice for the
- 10. Removal of such goods, and no liability, whatsoever, on the Bureau shall be attached for the rejected/disapproved goods/items/stores.
- 11. INSTALLATION: Bidder shall be responsible for installation / demonstration wherever applicable and for after sales service during the warranty and thereafter. If the supplier fails to supply, install and commission the system as per specifications mentioned in the order within the due date, the Supplier is liable to pay Penalty of one percent of the value of Purchase Order awarded per every seven days delay, subject to a maximum of 10% of the total value of the order and such money will be deducted from any money due or which may become due to the supplier.
- 12. The Bureau reserves the right to accept or reject summarily and/or all quotations in whole or part without assigning any reason whatsoever.
- 13. In case of any dispute arising out of this agreement then DG BIS shall nominate any officer of the BIS a sole arbitrator to adjudicate upon the issue involved in the dispute and the provisions of the Arbitration Act shall be applicable.
- 14. All question, disputes or differences arising under, out of or in connection with this Bid document shall be subject to the exclusive jurisdiction of Delhi/Ghaziabad Court.
