#### **PART-I: TECHNICAL BID**

# A: PRE-QUALIFICATION CRITERIA (PQC)

- 1. The bidder shall be PSU/ autonomous / public /private limited / Partnership/ Proprietorship / any other firm having been in business in India for the last three calendar years for supply of the same/similar equipment. The documents authenticating the establishment of the firm shall be submitted.
- 2. The bidder shall have supplied, installed and commissioned at least three such same/ similar equipment in India and one of them should be in the last three years. Additionally, the list of customers shall also be enclosed.
- 3. The bidder shall enclose copies of purchase orders/letters of satisfaction from buyers or any other document as a proof of supply of same / similar equipment to Govt. or private customers with the minimum value of order.
- 4. The bidder shall submit copies of audited balance sheets of last three years.
- 5. The bidder shall enclose valid proof of tax registrations as applicable to them such as GST/ PAN or any other registration for taxation purpose (for Indian Bidders). In case of foreign companies, bidders shall enclose valid proof of tax registrations from their own country.
- 6. The bidder should not have been blacklisted.
- 7. The bidder should not have earlier withdrawn from any tendering process of The Bureau.
- **8.** The Bidder shall be willing to provide after sales support through a combination of warranty and comprehensive annual maintenance contract for a period of 6 years as per mutually worked out terms and conditions

Note: The bidder shall enclose all requisite documents self-attested as specified in the checklist. The bidder must fill the checklist enclosed with relevant details.

# I Pre-bid Meeting

A Pre-bid meeting for interested Bidders will be held at the scheduled date and time indicated in the tender document. Any change in venue or timing of pre-bid meeting will be hosted on The Bureau website (<a href="www.bis.gov.in">www.bis.gov.in</a>) and the Central Public Procurement (CPP) Portal of Government of India (<a href="https://eprocure.gov.in/cppp">https://eprocure.gov.in/cppp</a>).

Interested Bidders will be allowed to seek clarification and get their doubts cleared during pre-bid meeting.

Any change that would be made in the Tender Document by the Competent Authority after issue of the Tender /Prebid meeting will be hosted on The Bureau website (www.bis.gov.in) and on CPP Portal of Government of India in the form of Corrigendum/Addendum for incorporating the same in the Bid before submission

The minutes of pre-bid meeting shall be intimated to all bidders present in the pre-bid meeting and shall also be exhibited on The Bureau website and on the CPP portal.

# II Availability of Tender Document:

The Tender document may also be downloaded from the website of The Bureau (<u>www.bis.gov.in</u> and the CPP Portal.

The bidder shall bear all costs associated with the preparation and submission of its tender. the bureau shall, in no case, be responsible or liable for these costs, regardless of the conduct or the outcome of the Bidding process.

# III Language of Bid/Contract:

The language of the Bid shall be in English/Hindi and all correspondences etc. shall conform to English/Hindi language.

#### IV Last Date for Submission

Tenders have to be submitted online on CPP Portal (https://eprocure.gov.in/eprocure/app). It shall be the responsibility of the bidder / tenderer to ensure that tender is submitted on before the deadline of submission prescribed.

Submission of Tenders shall be closed on CPP Portal mentioned earlier at the date & time of submission prescribed after which no bidder shall be able to submit the Tender.

It shall be the responsibility of the bidder / tenderer to ensure that his tender is submitted online on the CPP Portal (https://eprocure.gov.in/eprocure/app) before the deadline of submission. The Bureau will not be responsible for non-receipt of tender documents due to any delay or loss etc.

# V Manner of Submission of Bid

Bids shall be submitted online only at CPP Portal.

Bidders are advised to follow the instructions provided in the 'Instructions to the Contractors/Bidder for the esubmission of the bids online through the Central Public Procurement Portal. A set of instructions for online bid submission are enclosed. Bid documents may be scanned with minimum 100 dpi with black and white option which helps in reducing size of the scanned document.

Bidder who has downloaded the tender from The Bureau website and the Central Public Procurement Portal shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tempered/modified in any manner, bid will be completely rejected and EMD would be forfeited and Bidder may be banned from doing business with The Bureau.

E-mail or fax submission shall not be considered.

#### VI Contents of the bid document

The bidders shall submit their bids in two parts, one part of the bid shall be **Technical Bid** and second part **Financial Bid**.

#### VII BID Format

a) Price Schedule(s) as per the BOQ format filled up with all the relevant information to be uploaded in the form of BOQ PriceBid.xls.

The price bid format is provided as BOQ\_PriceBid.xls along with this Tender Enquiry Document at https://eprocure.gov.in/eprocure/app. Bidders are advised to download this BoQ\_XXXX.xls as it is and quote their offer/rates in the permitted column and upload the same in the commercial bid. The wages quoted shall be inclusive of the bonus payable by the contractor to the technical persons and the administrative charges (if any) deployed in The Bureau. **Bidder shall not tamper/modify downloaded price bid template in any manner**. In case if the same is found to be tempered/modified in any manner, tender will be completely rejected and tenderer is liable to be banned from doing business with The Bureau.

b) The authorized signatory of the bidder must digitally sign the bid. Bid sent by fax/email shall not be considered.

# B: INSTRUCTIONS TO BIDDERS (FOR STRICT COMPLIANCE)

# I DISCLAIMER

The information contained in the Tender Document, provided by the Bureau, is for information of the Bidders to assist them in formulation of their bids. Each Bidder can conduct their own investigation and analysis before submission of the bid. The Bureau shall not incur any liability, whatsoever, with regard to the completeness of the information contained in the Tender Document that the Bidder may require for submission of the bid. The Bureau reserves the right to amend any condition of the Tender Document through publication of a Corrigendum, besides rejection of any or all the bids received, if the Competent Authority of the Bureau decides so.

#### II ONLINE BID SUBMISSION

The bidder can bid for one or more than one equipment. The bidder has to bid for each equipment separately and provide EMD amount mentioned for each equipment separately for which he is submitting his bid.

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal. More information useful for submitting online bids on the CPP Portal may be obtained at: <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>.

Bidder should be responsible for registering his company at Central Public Procurement Portal and seeking all necessary approvals required to upload the bid.

The Bureau reserves the right to amend the document, tentative schedule and critical dates. It is the sole responsibility of prospective bidders to go through Central Public Procurement Portal / The Bureau Website from time to time for any updated information.

#### III REGISTRATION ON CPP PORTAL

- i. Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrolment" on the CPP Portal which is free of charge.
- ii. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- iii. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- iv. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- v. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- vi. Bidder then logs in to the site through the secured log-in by entering their user ID /password and the password of the DSC / e-Token.

#### IV SEARCHING THE TENDER DOCUMENT

- i. There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- ii. Once the bidders have selected the tenders they are interested in, they may download the required documents / tender Annexes. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- iii. The bidder should make a note of the unique Tender ID assigned to each tender; in case they want to obtain any clarification / help from the Helpdesk.

#### V PREPARATION OF BIDS

- i. Bidder should consider any corrigendum published on the tender document before submitting their bids.
- ii. Bidder should go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- iii. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / Annex and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- iv. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. GST/PAN, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

## VI SUBMISSION OF BIDS

- i. Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- ii. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- iii. Bidder has to select the payment option as "offline" to pay the EMD as applicable and enter details of the instrument. Bidder should pay the EMD as per the instructions specified in the tender document. The details of the NEFT/online instrument, should tally with the data entered during bid submission time. Otherwise the uploaded bid will be rejected. The EMD amount will be returned to the unsuccessful Bidders as per the provisions of GFR. It will be returned to the successful Bidder after receipt of the Performance Security.

**Forfeiture of EMD**: The Bid Security / Earnest Money deposited is liable to be forfeited if the tenderer withdraws or amends or impairs or derogates the offer in any respect within the period of

validity of the tender or if the successful Bidder does not pay the Performance Security in the prescribed time limit or fails to sign the Agreement after the award of Contract.

- iv. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it, enable Macro in the excel sheet and complete the coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.
- v. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- vi. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128-bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- vii. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- viii. Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- ix. The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

- 1. The Invitation for Bids is to be uploaded on two bids basis i.e. Technical Bid and Financial Bid.
- 2. It is the responsibility of the Bidder to ensure that the bids are up loaded on time within the deadline through www.eprocure.gov.in. A scanned copy of the EMD submitted needs to be uploaded at the Central Public Procurement Portal and the original instrument of EMD shall be submitted before the closing date and time to Sc F & Head, Bureau of Indian Standards, Central Laboratory, 20/9, Site-IV, Sahibabad Industrial Area, Sahibabad-201010, Ghaziabad (UP). Registered Micro & Small Enterprises (MSEs) as defined in MSEs Procurement Policy, 2012 issued by Department of Micro, Small & Medium Enterprises (MSME) or as registered with the Central Purchase Organisation or the concerned Ministry or Department or Start-ups recognized by Department of Industrial Policy and Promotion (DIPP) are exempted from payment of EMD on production of valid certificate of registration with the authority/agency as indicated in the policy.
- 3. All bids shall remain valid for 180 days from the last date of submission of bids.

- 4. The Bureau reserves the right to solicit additional information from Bidders.
- 5. The Bureau reserves the right to accept the whole, or part of or reject any or all bids without assigning any reasons and to select the Bidder(s) who, in the sole opinion, best meet the interest of The Bureau.
- 6. Although negotiations are severely discouraged, The Bureau also reserves the right to negotiate with the bidders placed as L1 bidder in the interest of The Bureau.

An FM clause in the contract frees both parties from contractual liability or obligation when prevented by such events from fulfilling their obligations under the contract. An FM clause does not excuse a party's non-performance entirely, but only suspends it for the duration of the FM. The supplier has to give notice of FM as soon as it occurs and it cannot be claimed ex-post facto. There may be a FM situation affecting Bureau of Indian Standards only. In such a situation, The Bureau of Indian Standards is to communicate with the supplier along similar lines as above for further necessary action. If the performance in whole or in part or any obligation under this contract is prevented or delayed by any reason of FM for a period exceeding 90 (Ninety) days, either party may at its option terminate the contract without any financial repercussion on either side.

#### **Test Details**

# 1. Clogging Test Using Coal

# 1.1 Principle

The test consists of drawing dry, dust laden air through a filtering half mask on the inhalation cycle of a sinusoidal breathing machine and blowing moist, dust free air through the filtering half mask during the exhalation cycle and determining the pressure drop across the filtering half mask following the collection of 1.5 g of dust. The test shall be conducted with the inhaled air at an ambient temperature of  $27 \pm 2$  °C and at  $65 \pm 5$  percent relative humidity and the exhaled air at  $37 \pm 2$  °C and 95 percent relative humidity minimum.

#### 1.2 Test Equipment




Fig 1 Typical Sinusoidal Dust Test Equipment/Setup for Clogging Test for Valveless Filtering Half Masks

A scheme of a typical apparatus is given in Fig. 1. The double acting breathing machine B (2 l/stroke, 15 cycles/min) and the critical orifice O in conjunction maintain the flow rate through mixing chamber C and nozzle A essentially constant at 95 l/min and 9.5 l/min respectively throughout the sinusoidal breathing cycle, so ensuring dust conditions within the chamber C.

For measuring the pressure drop and setting up flow through nozzle *A*, valve *X* is set at CALIBRATE; during these operations, the breathing machine is switched off. For testing the valve is set at TEST. For determining the quantity of dust which shall be introduced into the hopper *H* in order that 1.5 g be collected on the filtering half mask, valve *Y* is set at CALIBRATE; at this setting the flow rate during exhalation is zero.

# **1.3** Test Conditions

The dust used for the clogging test shall be coal dust ground by ball mill and graded by sieving, the portion which passes a 240 mesh (60 micrometre aperture) sieve being used for the test. The size distribution of coal dust is given in Table 1.

#### **1.4** Test Procedure

The test apparatus shall be setup connecting a weighed filtering half mask into the air circuit at the top of chamber *C*. Valve *X* shall be set to CALIBRATE and air shall be drawn through the filtering half mask at 95 l/min; valve *E* shall be adjusted until the flow through the nozzle *A* is 9.5 l/min. Valve *X* shall then be set to TEST and valve *Y* to CALIBRATE, a known weight of dust shall be fed into the hopper *H* and dispersed into the chamber. After dispersal, the filtering half mask shall be re-weighed. A number of filtering half masks shall be exposed until the weight of dust which shall be introduced into the hopper to give a 1.5 g collection is determined.

Connect the filtering half mask into the chamber. Valve Y shall be set to TEST, the previously determined weight of dust shall be introduced into the hopper H and after allowing the filtering half mask to reach equilibrium the dust shall be dispersed into chamber C. After dispersal valve X shall be set to CALIBRATE and the breathing machine turned off. The pressure drop across the filtering half mask at 95 1/min shall be read off manometer M.

Repeat the test on the other two samples and report the 3 recorded pressure drops. After completion of the clogging test, the filtering half masks shall be allowed to stabilize in the laboratory for 24 h at the end of which the filtration efficiency of each filtering half mask shall be determined.

#### 2 Clogging Test Using Dolomite Dust

#### **2.1** Principle

The test consists of subjecting the filtering half mask to a sinusoidal breathing simulation. The sample is surrounded by a known concentration of dolomite dust in air. Following the exposure, the breathing resistance and the filter penetration of the sample filtering half masks are measured.

# 2.2 Test Equipment




Figure 2 Typical Sinusoidal Dolomite Dust Prest Equipment/Setup for Clogging Test

A scheme of a typical apparatus is given in Fig. 2. The working area of the test chamber has a suggested square section of 650 mm  $\times$  650 mm. The breathing machine has a displacement of 2 l/stroke. The exhaled air shall pass a humidifier in the exhaled air circuit, such that the exhaled air temperature, measured at the position of the sample filtering half mask is 37  $\pm$  2 °C and 95 percent relative humidity minimum.

#### 2.3 Test Conditions

- a) DUST: DRB 4/15 dolomite. The size distribution of dolomite dust is given in Table 2.




Figure 3 Particle Size Distribution of Dolomite Dust in the Test Chamber

- b) The particle size distribution of the air borne dust at the working area of the dust chamber is given in Fig. 3. This characteristic is an essential parameter, which shall be verified especially if the geometry of the test chamber is somewhat different from the model described in this standard.
- c) Continuous flow through the dust chamber: 60 m<sup>3</sup>/h, linear velocity 40 mm/s.
- d) Sinusoidal flow through the filtering half mask is delivered by a breathing machine adjusted to 15 cycles/min and 2.0 l/stroke; the exhaled air shall be saturated in humidity.
- e) Concentration of the dust:  $400 \pm 100 \text{ mg/m}^3$
- f) Temperature of the air:  $27 \pm 2$  °C
- g) Relative humidity of the air:  $45 \pm 15$  percent
- h) Testing time: Until the product of measured dust concentration and exposure time is 833 mg.h/m³ or until:
  - 1) for valved filtering half masks, the peak inhalation resistance (corresponding to a continuous flow of 95 l/min) has reached 4 mbar for class FFP 1, 5 mbar for class FFP2 and 7 mbar for FFP3 or until the peak exhalation resistance (corresponding to a continuous flow of 160 l/min) has reached 3 mbar; and
  - 2) for valveless filtering half masks, the peak inhalation or the peak exhalation resistance (corresponding to a continuous flow of 95 l/min) has reached 3 mbar for FFP1, 4 mbar for FFP2 and 5 mbar for FFP3.

NOTE -  $833 \text{ mg.h/m}^3$  corresponds to inhaling a total volume of air laden with 1.5 g of dust. This is represented, for example, by a dust concentration of  $400 \text{ mg/m}^3$  and an exposure time is 125 min. Because of the dust losses on exhalation the cumulative weight of dust collected on the filtering half mask will probably be less than 1.5 g. For this reason, there is no purpose in weighing the sample filtering half mask.

#### 2.4 Test Procedure

Dust from the distributor shall be conveyed to the dust chamber where it shall be dispersed into the air stream of  $60 \text{ m}^3/\text{h}$ .

The sample filtering half mask shall be fitted in a leak tight manner to a dummy head or a suitable filter holder located in the dust chamber. The breathing machine and humidifier shall be connected to the sample and shall be operated for the specified testing time.

The concentration of dust in the test chamber maybe measured by drawing air at 2 l/min through a sampling probe equipped with a pre-weighed, high efficiency filter (open face, diameter 37 mm) located near the test sample as shown in Fig. 4.


The dust concentration shall be calculated from the weight of dust collected, the flow rate through the filter and the time of collection. Other suitable means may be used.


# 2.5 Assessment of Clogging

Following the exposure, the breathing resistance of the filtering half mask shall be measured using clean air and the filter penetration shall then be measured in accordance with **Annex XX**.

The person signing the offer or any other document forming the part of Contract on behalf of other persons of a firm shall be deemed to have due authority to bind such (person/s) or the firm as the case may be, in all matters pertaining to the Contract. If it is found that the person concerned has no such authority, The Bureau may, without prejudice to any other Civil/Criminal remedies, terminate the Contract and hold the signatory and / or the firm liable for all costs and damages for such termination.

#### c) PERFORMANCE SECURITY

- i) For Foreign Supplier: The successful bidder shall furnish within 15 days of placement of the order an unconditional Performance Bank Guarantee from a Nationalized/ scheduled Bank for 10% of the order value. Performance Security should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. On acceptance of this condition and submission of Bank Guarantee, the Letter of Credit will be opened for 100% order value at The Bureau HQ/ by concerned lab. If the firm fails to submit the same, the Contract shall be deemed as terminated and the firm's EMD will be forfeited. Performance Security will be furnished in the form of DD/PO favouring BUREAU of INDIAN STANDARDS (payable at ......)/Performance Bank Guarantee as per format indicated in Annexure-5.
- ii) For Indian Supplier: The successful bidder shall submit, within 15 days of the placement of the order, an unconditional Performance Bank Guarantee from a Nationalized/scheduled Bank for 10% of the order value, as per format indicated in Annexure-5. Performance Security will remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations.

Any amount due/recoverable from the Supplier/ Contractor under the terms of this Contract or any other account, may be deducted from the amount of Performance Security In case, the amount of Performance Security is reduced by reason of any such deduction, the Supplier/ Contractor shall, within <u>fifteen (15)</u> days of receipt of notice of demand from The Bureau, make good the deficit. In case, security is deposited by way of bank guarantee by the Supplier/ Contractor, then any penalty for damages liquidated or unliquidated or for any breach or failure or determination of Contract, not previously paid to The Bureau, shall immediately on demand be paid by the said bankers to The Bureau under and in terms of the said guarantee.

If during the term of this Contract, the Contractor is in default of the due and faithful performance of its obligations under this Contract, or any other outstanding dues by the way of fines, penalties and recovery of any other amounts due from the Contractor, The Bureau shall, without prejudice to its other rights and remedies hereunder or at the Applicable Law, be entitled to call in, retain and appropriate the Performance Security.

Nothing herein mentioned shall debar The Bureau from recovering from Contractor by a suit or any other means any such losses, damages, costs, charges and expenses as aforesaid, in case the same shall exceed the amount of the Performance Security.

The Performance Security shall be retained until all disputes, if any, between both the parties have been settled to the entire satisfaction of The Bureau. The Performance Security shall be returned to the Contractor by The Bureau within sixty days following the Completion Date or Termination Date of this Contract provided that there are no outstanding claims of The Bureau on the Contractor.

## d) CONTRACT DOCUMENTS:

The several Contract documents forming the Contract shall be taken as mutually explained to one party by the other, but in case of ambiguities or discrepancies the same shall be explained and harmonized by the Authorized Officer of The Bureau who shall issue to the Contractor necessary instruction thereon and in such event unless otherwise provided in the Contract the priority of the documents forming the contract shall be as follows:

- i) The Agreement
- ii) The terms and conditions of the Contract
- iii) Tender Notice and Tender Document
- iv) Purchase order or Letter of Acceptance
- v) Any other correspondence exchanged between the parties in connection with the contract.
- vi) The Contractor's Offer

# 5. QUANTITY OF GOODS or PLACE OF SUPPLY or PERSONS WHO CAN PLACE ORDERS

Goods for Central Laboratory can be ordered by Head of that Central Laboratory only, who is authorized by The Bureau to place orders against this Contract. However, the Authorized Officer reserves right not to place repeat orders.

Immediately on receipt of the purchase order within one week of receipt of the purchase order, the contractor or supplier shall intimate the concerned laboratory about the consumables or other additional articles required for correct functioning of the instrument or equipment, so that timely installation and commissioning can be done, and no time is lost in completion of such formalities after receipt of the instrument or equipment.

#### 6 TRANSPORTATION:

The supplier is required to ensure having an import license for the equipment quoted where applicable as per GOI guidelines. The Goods shall be delivered at the destinations specified in Clause 8 below and shall include loading, unloading and transportation. **The Goods damaged during transportation shall have to be replaced at Contractor's cost.** The successful bidder shall be responsible for necessary customs clearance.

# 7. QUALITY OF GOODS:

**9. INSTALLATION AND COMMISSIONING:** Installation and commissioning of the equipment will be done by the supplier **FREE OF CHARGE** at the consignee's premises. The supplier has to arrange for labour and others.

#### 10 WARRANTY

10.1 The equipment along with all critical components or accessories is to be guaranteed for trouble free performance for a **minimum period of three years after installation.** If the warranty period is less than three years, the Comprehensive Annual Maintenance Contract Charges for the remaining period (three years – the actual warranty period quoted) shall be added to the cost of equipment for the purpose of evaluation of the financial bid.

10.2 The defects, if any, during the warranty period shall be rectified free of charge by arranging free replacement at site, wherever necessary. The last six months of the warranty period shall be free of complaints, failing which the warranty period will get extended by another six months.

#### 11. FREE TRAINING

Training, free of cost will be provided by the supplier to at least two officials of The Bureau for testing, routine maintenance and smooth running of the equipment, after installation and commissioning at the location.

# 12. INSPECTION or PRE-DELIVERY INSPECTION

The Bureau reserves the right to carry out predelivery inspection or inspection at the time of delivery. The obligation to supply goods conforming to specification and its successful installation and commissioning shall be on the supplier.

The Authorized Officer shall be entitled to inspect and examine goods intended to be supplied to The Bureau either at the factory, godown or at any place(s) where these are lying or from which these are being obtained and the supplier shall provide such facilities as may be required for such inspection and examination. If goods are not found as per specified requirements, purchase order will be revoked and thereafter The Bureau shall be free to purchase the goods from the open market. The Bureau will not make any payment for any such non-conforming goods.

All goods shall be inspected by The Bureau preferably in the presence of supplier or his authorized representative, when the packages are opened in The Bureau Labs on delivery and prior to installation. The decision of The Bureau shall be binding. Rejected items or goods or stores shall be removed by the supplier at his own cost and risk, within 30 days of receipt of notice for the removal of such goods, and no liability, whatsoever, on The Bureau shall be attached for the rejected or disapproved goods or items or stores. In case of default on the part of the supplier in removing the rejected goods, the Authorized Officer of The Bureau shall be at liberty to have them removed by other means. The Authorized Officer shall have full powers

to procure other goods through other means for substituting the rejected goods. All costs, which may be incurred upon such removal and/or substitution, shall be borne by the supplier.

The Authorized Officer shall have full powers to decide about removal of any or all of the goods supplied which are not in accordance with the contract specifications or which do not conform to the samples, if any, approved by The Bureau.

#### 13. TIME FOR SUPPLY, INSTALLATION AND COMMISSIONING.

- 13.1 The time allowed for delivery, successful installation and commissioning shall be 8 weeks from the date of purchase order (PO). In case of foreign suppliers, the date of delivery, successful installation and commissioning shall be within 8 weeks of opening of Letter of Credit (LOC).
- 13.2 **Liquidated Damages for Delayed Supply Installation and Commissioning:** Time and date of **Supply Installation and Commissioning of equipments** as stipulated in the order shall be deemed to be the essence of the contract. In case of delay in execution of the order beyond the date of delivery as stipulated in the order or any extensions sanctioned by the Authorized Officer, The Bureau may at its option either: -
- 13.3.1 Accept delayed delivery at prices reduced by a sum equivalent to one percent (1%) of the value of any goods not delivered for every week of delay or part thereof limited to a maximum of 10% of the total order value.
- 13.3.2 Cancel the order in part or full and purchase such cancelled quantities from elsewhere on account and at the risk of the bidder, without prejudice to its rights in respect of goods delivered.

#### 14. RISK PURCHASE

In case the Contractor fails to deliver the quantity as stipulated in the delivery schedule, The Bureau reserves the right to procure the same or similar Goods from alternate sources at the risk, cost and responsibility of the Contractor.

### 15. IMPOSITION OF FINES or PENALTY

Subsequent to an order being placed against the quotation received in response to this enquiry if it is found that the goods supplied are not of the right quality or not according to specifications required by The Bureau or received in damaged or broken condition or otherwise not satisfactory owing to any reason of which The Bureau shall be the sole judge, The Bureau shall be entitled to reject the goods, cancel the contract and buy its requirements in the open market and recover the loss, if any, from supplier reserving to itself the right to forfeit the security deposit, if any, furnished by the supplier against the contract. The supplier will make his own arrangements to remove the rejected goods within 30 days of instruction to do so. Thereafter, they will lie entirely at the supplier's risk and responsibilities and storage charges along with any other charges applicable will be recoverable from the supplier.

#### **16. TERMS OF PAYMENT:**

A) The Terms of Payment are: The successful bidder shall furnish within 15 days of placement of the order a Performance Security, from a Nationalized or Scheduled Bank for 10% of the order value. Performance Security should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. On acceptance of this condition and submission of Performance Security, as given in 3 of Part-III, the Letter of Credit will be opened for 100%

order value. If the firm fails to submit the same, the Contract shall be deemed as terminated and the firm's EMD will be forfeited. The Performance Security shall be furnished in the bank account of Bureau of Indian Standards Central Laboratory, Sahibabad (payable at Ghaziabad) or Performance Bank Guarantee as per format indicated in Annexure-5.

# B) Payment to foreign suppliers:

- i) **Payment for imported items**: 80% payment shall be made by an Irrevocable Letter of Credit established in favour of the supplier at The Bureau HQ or by concerned laboratory of The Bureau, for the order value against the presentation of original shipping documents provided that the Performance Security for 10% of the order value within 15 days of placement of the order is given to The Bureau. 20% of the order value of goods received shall be paid within 30 days of receipt of the goods and successful installation, **commissioning & training** upon submission of claim supported by the acceptance certificate issued by the Purchaser along with the Performance Security.
- Payment for indigenous items: 100% payment shall be made against delivery, installation, commissioning, training at site and on acceptance as per Purchase Order provided, that the Performance Security for 10% of the order value, within 15 days of placement of the order is given to The Bureau.
- C) **Payment for Indian Suppliers:**100% payment shall be made against delivery, installation, commissioning, training at site and on acceptance as per Purchase Order provided, that the Performance Security for 10% of the order value, within 15 days of placement of the order is given to The Bureau.

#### 17. TAXES

Taxes will be deducted by The Bureau wherever applicable.

#### 18. INDEMNITY:

The Contractor shall indemnify and keep indemnified The Bureau against all losses and claims for injuries or damage to any person or any property whatsoever which may arise out of or in consequence of the Contract and against all claims, demands, proceedings, damages, costs, charges and expenses whatsoever in respect of or in relation thereto under the provisions of various labour laws as amended from time to time. The Contractor shall indemnify, protect and save The Bureau against all claims, losses, costs damages, expenses, action suits and other proceeding, resulting from infringement of any patent, trademarks, copyrights etc. or such other statutory infringements.

# 19. CORRUPT OR FRAUDULENT PRACTICES

The Bureau requires that the Bidders under this Bid observe the highest standards of ethics during the procurement and execution of such Contracts.

The Bureau will reject a proposal for award if it determines that the Contractor has engaged in corrupt or fraudulent practices before, during or after the period of contract; The Bureau will hold the Contractor ineligible to be awarded a contract, either indefinitely or for a period of 24 months from the date of declaring the contractor ineligible if it at any time determines that the Contractor has engaged in corrupt and fraudulent practices in competing for, or in executing the Contract.

# 20. THE BUREAU MAY TERMINATE THE ORDER, IF

(a) The Contractor becomes insolvent;

- (b) A receiver, administrator, trustee or liquidator is appointed over a substantial part of its assets;
- (c)Any act is done or event occurs with respect to the Contractor or its assets, which, under any applicable law has substantially similar effect to any of the foregoing acts or events;
- (d) Serious discrepancy in the quality of the Goods is noticed during the inspection.
- (e) Delays in delivery beyond the scheduled date of delivery as stipulated in the order or any extensions sanctioned.
- (f) Delays in installation and commissioning beyond the period stipulated or any extensions sanctioned.
- (g) If the Contractor is in breach of any law or statute governing the supply of Goods or Services;
- (h) The Contractor, in the judgement of The Bureau, has engaged in corrupt or fraudulent practices in competing for or in carrying out the Services under the Contract.
- (i) The Contractor enters into voluntary or involuntary bankruptcy or liquidation.

It shall also be lawful for The Bureau to terminate the Agreement at any time without assigning any reason and without being liable for loss or damage which the Contractor may suffer by reason of such termination, by giving the Contractor 15 days' notice in writing by The Bureau for such termination. Any such termination shall be without prejudice to any other right of The Bureau under the Contract.

If the Contractor decides to terminate the Contract before the end of contract period, the Contractor has to give an advance intimation of at least 60 days. If the Contractor terminates the agreement without prior notice of 60 days, then the entire security deposit will be forfeited.

#### 21. PUBLICITY

Any publicity by the Contractor in which the name of The Bureau is to be used, should be done only with the explicit written permission of The Bureau.

#### 22. JURISDICTION

No suit or other proceedings relating to performance or breach of Contract shall be filed or taken by the Contractor in any Court of law except the competent Courts having jurisdiction in New Delhi, where headquarter of The Bureau is located.

**23. DISPUTE RESOLUTION** - In case of any dispute that cannot be resolved amicably, the same shall be referred to the sole Arbitrator appointed by Director General, Bureau of Indian Standards, whose decision shall be final and binding upon both the Bureau as well as the Applicant. The provisions of the Arbitration and Conciliation Act, 1996, as amended from time to time, shall be applicable

# 24. MODE OF SERVING NOTICE

Communications between Parties which are referred to in the Contract are effective only when in writing. A notice shall be effective only when it is delivered. All notices shall be issued by the authorized officer of The Bureau unless otherwise provided in the Contract. In case, the notice is sent by registered post or speed post to the last known place or abode or business of the Contractor, it shall be deemed to have been served on the date when in the ordinary course of post these would have been served on or delivered to it.

# 25. GOVERNING LANGUAGE

Governing language for the entire contract and communication thereof shall be English and/or Hindi only. In case of any dispute, the English version shall prevail.

## 26. LAW:

The contract shall be governed and interpreted under Indian Laws.

#### 27. STAMP DUTY

The Contractor shall bear and pay any stamp duty and registration charges if any, in respect of the agreement to be signed.

#### 28. AUTHORIZED OFFICER:

The Authorized Officer on behalf of The Bureau shall be the Head, of the Central Laboratory giving the purchase order. In case of repeat orders by any other Laboratory of the Bureau, the Head of concerned Laboratory of the Bureau placing the repeat order shall be deemed to be the Authorized Officer in respect of the said order.
