CORRIGENDUM/ ADDENDUM 02

Sub: REQUEST FOR PROPOSAL FOR APPOINTMENT OF MANAGEMENT CONSULTANT FOR STRATEGIC TRANSFORMATION SUPPORT FOR BUREAU OF INDIAN STANDARDS (BIS)

With reference to the above mentioned RFP, Corrigendum/Addendum No 02 is hereby issued as under:-

1. Ref Page 8, Clause (e) –Add the following line, *“It is encouraged to adhere to the 75 page limit, an executive summary is required along with the proposal.”*
2. Ref Page 22, Section 7.2, Serial 4, Column 2–Replace (2 marks) by (4 marks)
3. Ref Page 23, Section 7.2, Serial 5, Column 2–Replace (2 marks) by (5 marks)
4. Ref Page 23, 10th paragraph, Line 2-4 - Replace the line *“The financial proposal should be for Phase I. Phase II financial fees will be assumed to be equal to Phase I.”* with *“The bid will be a single bid for 14 months (Phase 1 + Phase 2)”*.
5. Ref Page 42, Form FP2, Column 3 – Replace *“Basic rate fees quoted exclusive of taxes for the first six months of the project”* with *“Basic rate fees quoted exclusive of taxes for the complete project.”*
6. Ref Page 42, Form FP2, Column 3 – Replace *“same quote will apply for Phase II (six months) and also”* with *“same quote will apply.”*
7. Ref Page 17, Section 3, 1st Paragraph, Line 4-5 - Replace *“This data/study will be available to the Consultant at the beginning of Phase I and a soft copy will also be provided with the RFP”* with *“This data/study will be available to the Consultant at the beginning of Phase I”*.
8. Ref Page 21, Clause 7.2, Serial 2, Column 3, 3rd Sentence – Replace existing sentence with the following *“Should have worked in the field of transformation/change management. The expert should have worked with at least 3 clients and above 6 months of assigned duration.”*
9. Ref Page 19, Section 6, 4th Paragraph, Line 2 - This line is added *“The bidders eligible after the minimum qualification criteria will need to make a presentation on their Approach and Methodology/ Roadmap to attain project objectives. The date of this presentation will be announced in advance.”*
10. The updated dates for Receipt of offers and Opening of bid are as follows:
Receipt of offers: 23-April-18, up to 5:30PM
Opening of Bid: 24-April-18, 3:00PM

Other terms and conditions of the RFP shall remain same.
