Bureau of Indian Standards, Mumbai intends to dispose-off unserviceable/obsolete Equipments as listed in the Annexure I on as is where is basis as per the terms and conditions mentioned below. You are requested to submit your quotations for the items as given in Annexure I for individual items. Quotation for part of the lot would not be accepted. Copy of the Annexure I duly signed can be used for submitting the bids. Bids not meeting the terms & conditions of the tenders would be summarily rejected.

2. Quotation shall be submitted in a sealed envelope supercribed '**Quotation for Disposal of Unserviceable/Obsolete Equipments**' and should reach Head (Laboratory) latest by **1530 hours on 2 March 2010. The same shall be opened at 1600 hrs on the same day.** Tenderer or his authorised representative may like to be present at the time of opening of the quotation if desired so.

3. The quotation shall be accompanied with Earnest Money Deposit (EMD) of Rs.2000.00 (Rs. Two thousand only) through **Demand Draft only** in favour of **Bureau of Indian Standards, Mumbai.** In the event of non-acceptance of quotation the EMD shall be refunded. The quotation not accompanied with EMD shall be rejected. **CASH OR CHEQUES SHALL NOT BE ACCEPTED.** No interest shall be payable on Earnest Money Deposit.

4. The EMD of the successful bidder shall be retained by the Bureau as performance security and would be adjusted against full and final payment. For other parties, it shall be refunded after finalization of the tender.

5. The items offered in the Annexure may be inspected at the premises of Bureau at Manakalaya, Laboratory, E-9 (Behind Telephone Exchange) MIDC, Road No.8, Andheri (East) Mumbai-400 093, anytime between 1400 h to 1600 h on any working day between Monday to Friday with prior intimation.

The successful bidder shall have to take delivery of material within **15 days** on any working day between Monday to Friday during office hours against full payment in advance failing which, the Earnest Money Deposited shall be forfeited. The quotations shall remain open for acceptance for a period of 60 days from the date of opening of quotations.


