Quotation in sealed cover superscribing **"Quotation for disposal/sale of condemned Lab Equipment"** should reach the office at the above address latest by **1300 hrs** on **20 September 2013** which shall be dropped in **"Tender Box"** kept in **ground floor** in front of Security of the office.
2. The quotation must be accompanied with a drawn Demand Draft for an amount of **5%** of the quoted value of the equipment(s), drawn in favour of **"Bureau of Indian Standards"** payable at Kolkata as Earnest Money. Quotation without Earnest Money or the earnest money received in Cheque in place of demand draft will be summarily rejected. Earnest Money shall be refunded in the event of non-acceptance of the quotation. No interest will be paid on Earnest Money.
3. All the equipment as **mentioned in "Annexure A"** shall be sold by BIS on **"AS IS WHERE IS BASIS"**. The equipment as mentioned in the list may be inspected at the premises of ERO Lab at the above address between **1100h-1500h** on any working day on **Monday, Wednesday and Friday**.
4. Rate should be quoted separately against each equipment **indicated in Annexure-A**. Quotation received shall be opened at **1500h on 20 September 2013** in the presence of bidders or their authorized representative who may desire to be present at the time of opening of quotations.
5. The successful bidders shall have to take delivery of the material **within 15 days** from the date of issue of the orders from this office, after depositing full amount either in cash or in Demand Draft drawn in favour of this **Bureau of Indian Standards payable at Kolkata** failing which earnest money deposited will be forfeited. Lifting of the equipment shall be done in the presence of BIS officials.

13. In case of non-compliance with the order within stipulated time on account of any reason, the Bureau of Indian Standards, Kolkata reserves the right to :


- (i) Cancel/rescind/revoke the order.**
