1. Quotation in sealed cover super scribing "**Quotation for tested samples/remnants/scrap**" should reach undersigned at the above address **latest by 1600h on 20.10.2011**. The rate should be quoted for all items. **The items are lying in the scrap yard at the basement of the laboratory. Bureau of Indian Standards reserves the right to take decision to sell tested samples/ the scraps as individual item basis or as a complete lot.**
2. The quotation must be accompanied with a drawn **Demand Draft for Rs.3000.00 in favour of Bureau of Indian Standards payable at Kolkata as Earnest Money. Quotation without Earnest money shall be summarily rejected.** Earnest money shall be refunded in the event of non-acceptance of the quotation. No interest will be paid on Earnest money. Payment of Earnest money by cheque will not be entertained.
3. The tenderer participating in the tender may be **preferably Registered Scrap Dealers** who shall furnish documentary proof on the subject along with the quotation.
4. The entire lot of tested samples/ remnants/ scraps shall be sold by BIS on "**AS IS WHERE IS BASIS**". The material as mentioned in the list may be inspected at the premises of ERO Lab at the above address between **1100h-1500h** on any working day from **Monday to Friday**.
5. Quotations received **shall be opened at 1200h on 21.10.2011** in the presence of such tenderers or his authorized representative who may desire to be present at the time of opening quotations.

6. The successful tenders shall have to take delivery of the material **within 15 days on receipt of** order from Bureau of Indian Standards . Kolkata , after proper weighment and depositing full amount either in cash or in Demand Draft drawn in favour of this Bureau of Indian Standards payable at Kolkata .failing which earnest money deposited will be forfeited. Weighing of the material shall be done in the presence of BIS officials.
7. In the process of removing the material from our stores/ disposal scrap yard, the tenderer will be responsible for the loss/ damage of any property of the Bureau due to negligence on his part or on the part of his representative and the amount of loss shall be recovered from the tenderer.
8. Duties/ taxes wherever applicable/ lived by the Central/ State/ local bodies shall be borne by the tenderer and the amount quoted in the offer for various items shall be payable to the Bureau.
9. Charges for weighing, packing and lifting of the material shall be borne by the tenderer.
10. Quotations shall remain open for acceptance for a period of 60 days from the date of opening of the quotation.
11. **The Bureau of Indian Standards, Kolkata reserves the right of accepting/ rejecting full or part of the quotation(s) or portion of the quantity offered, without assigning any reasons whatsoever.**
