Tender in two bids is invited by NITS to award the contract. The General Terms and Conditions, Technical Bid including Scope of Work, and Financial Bid are enclosed. The tender document may either be downloaded from our website www.bis.org.in or may be collected from our office at the above-mentioned address on any working day i.e. Monday to Friday during 0930-1700 hrs. Bidders are requested to quote their most competitive offer for conducting the above training course. The offer should fulfil all terms, conditions and requirements of the tender document including scope of work.

The Technical and Financial bids shall be submitted in two separate sealed envelopes written clearly “**Tender No. TI/G-86/LA 18001 (Tender) – Technical Bid**” and “**Tender No. TI/G-86/LA 18001 (Tender) – Financial Bid**”. The duly filled Tender shall reach the office of “**Head, NITS**” at the above address **(to be dropped personally in the tender box, kept in the administrative hall of NITS or posted)** by **1200h** on or before **28 May 2010**. The tenders received after the **due date** shall summarily be rejected.

The Technical Bids shall be opened on the closing/last day of submission of tender at 1600 hrs or the next working day. The representatives of the bidders may be present at the time of opening of the tender, if interested. Financial Bids of only those tenders shall be opened, which qualifies in technical bid.

6. The Technical and Financial bids shall be submitted in two separate sealed envelopes written clearly **“Tender No. TI/G-86/LA 18001 (Tender)– Technical Bid”** and **“Tender No. TI/G-86/LA 18001 (Tender)– Financial Bid”**. The duly filled Tender shall reach the office of **“Head, NITS”** at the above address **by 1200h** on or before **28 May 2010**. The tenders received after the **due date** shall summarily be rejected.
7. The representatives of the bidders may be present at the time of opening of the tender, if interested. The FINANCIAL Bids of only those tenders shall be opened, which qualify in technical bid.
8. Each page of the tender document i.e. technical bid, financial bid and general terms, conditions including all annexure shall be duly signed by the bidders as a token of acceptance.
9. The terms, conditions and scope of work may be extended to cover more programmes in the same period, if required.
10. The interested bidders may visit NITS to familiarise with the place, facilities and the logistics available with NITS or may obtain information on any working day during working hours (Monday to Friday, 1000-1700 hrs).
11. NITS reserves the right thereto without assigning any reason to accept or reject any or all tenders in whole or in part.
12. Required documents duly attested shall be submitted strictly as prescribed. Non-receipt of any information or evidences with “tender” shall entail rejection of the tender.

13. The bidder shall enclose with the “tender”, the documents indicating the set up of the organization (partnership, proprietorship, private limited or public limited etc).
14. The Contractor (Successful bidder), after award of contract, shall send his acceptance of the Contract on his letterhead duly signed by the Chief Executive or Authorized Signatory of the organization.
15. If the services and the performance of the Contractor is not found satisfactory by NITS after the award of Contract, NITS shall reserve the right to terminate the Contract by giving 15 days notice without assigning any reason.
16. The Contractor shall abide by the terms and conditions indicated in the award of contract letter and the tender document in all respects.
17. The forwarding letter of the tender shall contain all the required annexure in support of their eligibility.
18. In the case of any dispute, the decision of the Head of NITS shall be final and binding.
19. In the event of any dispute or difference relating to the provisions of the contract, the same shall be settled amicably through mutual discussions, or shall be referred to the sole arbitrator appointed by the Head, NITS.
20. The courts at NOIDA (Gautam Budh Nagar) alone shall have the jurisdiction in any matter arising out of or relating to or touching this agreement.

Name of the Work : Conduct of Accredited 5-days Lead Auditors Course on OHSMS 18001/IS 18001 (OHSMS)

1. NITS intends to organize six (06) to ten (10) accredited 5-days Lead Auditors Courses on OHSMS 18001/IS 18001 for the years 2010-11 and 2011-12.
2. The bidder shall have prior experience in this field and have conducted minimum 20 such courses. Evidence to this effect is also required to be submitted by giving details of dates, venue and number of participants in each programme on letter head of organizations.
3. The summary of feedbacks from participants for each of last ten programmes organized on the subject shall also be provided.
4. The bidder shall submit evidence of Accreditation. The evidence shall also indicate the period for which the authorization has been given.
5. The bidder shall provide faculty approved by Accreditation Body for the course. The Lead Faculty shall be a Registered Lead Auditor. NITS may provide the second faculty.
6. The bidder shall be able to organize and conduct the course for NITS with an advance notice period of 45 days by NITS or as decided mutually. However, the dates shall be mutually agreed and fixed.

SCOPE:

1. The course shall be of 5-days (40 hours) duration.
2. Besides the basic understanding of OHSMS 18001/IS 18001, the course shall also cover the guidance specified in IS 18001.
3. The course shall be accredited and in line with OHSMS 18001/IS 18001 and IS/ISO 19011.
4. The course shall include case studies and practical exercises on auditing.
5. All the participants shall be provided with the copies of the all training materials, exercises, case studies and auditing exercises. One extra copy of each document shall be provided for the organizer, i.e. NITS.

6. Necessary facilities during complete working hours (0830 h – 1800 h) for trainers shall be provided by NITS. Overhead Projector, Laptop/Computer, LCD projector and other logistics such as marker pens, transparencies, photocopying facility etc. shall be arranged by NITS.
7. Pre-course material and the Course manual shall be provided in advance for distribution to participants in case it is required.
8. Total number of participants shall be 20 maximum per course and any extra participant(s), if permitted by the course provider, shall be allowed to attend the course and shall be eligible to receive the Certificate(s).
9. All participants shall be provided with the Certificates of successful completion in accordance with the terms of Accreditation Scheme. An examination may be conducted at the end of the course as per requirements of Accreditation Body. The Certificate shall carry the logo of BIS and the signature of the Head of National Institute of Training for Standardization, as well as that of the course provider.
10. NITS shall provide training venue, lunch, tea etc. for the participants. The courses are likely to be organized at NITS, Noida. However, the courses may also be held at other stations. In case, the course is organized outside Delhi/NCR, the travel charges by air (economy class) or train (AC II) and stay arrangements as applicable to BIS Officers shall be arranged by the bidder, which will be reimbursed separately by NITS on the production of proofs thereof.

1. This Envelope shall contain only the “Financial Bid” of Tender Document i.e. the rates quoted.
2. No commercial/technical condition or qualification of any sort shall be indicated by the bidder in this envelope, otherwise the tender shall be summarily rejected.
3. All the rates quoted shall be firm and inclusive of service tax and all other charges. Any escalation of rates shall not be permissible during the validity period of the Contract. NITS shall not pay any additional charges. The rates shall be inclusive of all local expenses, whenever the programmes are organized at NITS, Noida. In case, the course is organized outside Delhi/NCR, the travel charges by air (economy class) or train (AC II) and stay arrangements as applicable to NITS Officers shall be arranged by the bidder which will be reimbursed separately by NITS on the production of proofs thereof.
4. The bidder shall quote most competitive rates per programme, for each of the following:
 - a) When both faculty for the course are from Bidder
 - b) When only the Lead Faculty is from the bidder and the second faculty from BIS
 - c) When both the faculty are from BIS
5. **Terms of Payment** (in the case of successful bidder who will be given the contract):
 - a) The contractor shall submit the bill for payment within one month of the completion of the course in duplicate in the name of “National Institute of Training for Standardization, Noida”.
 - b) 100% payment shall be made after completion of the course and submission of the bill for the same. Normal processing time for the bill processing for payment shall be allowed.
 - c) TDS shall be deducted from the bill as per the prevailing Income Tax rules.
