

1. The base value of all the items is Rs. 50,000/-, hence quote less than this amount will not be accepted.
2. The above material can be inspected before submission of the quotation on any working day between 1000h and 1600h.
3. The rates must be quoted for the entire lot only and not for each item separately.
4. Each bidder has to deposit a sum of **Rs.5000/- as Earnest Money Deposit** by way of Demand Draft in favour of the **Bureau of Indian Standards payable at Chennai** along with their quotation. **Quotations received without EMD shall be summarily rejected. The EMD of Rs. 5000/- received from the unsuccessful bidders will be returned.**
5. The successful Bidder shall be required to deposit within a week of awarding contract a sum of **Rs.10,000/- as Caution Deposit** for performance/obligation arising out of the contract. Failure to deposit the Caution Deposit by the due date will lead to cancellation of the contract and forfeiture of the EMD. Caution Deposit amount will not be adjusted with the earlier deposited EMD amount.
6. Engaging manpower and relevant equipments/accessories required for removing the items will be borne by bidder.
7. Full amount quoted by the bidder shall be deposited before lifting the material.
8. The material will have to be lifted by the successful bidder on any mutually decided and convenient working day (Monday to Friday) between 1000h to 1600h except Saturdays, Sundays and Public Holidays failing which the Bureau is not responsible for any loss, theft, pilferage etc. All the items have to be lifted in eco-friendly manner without any hindrance to our normal work
