 - (vii) Minimum Contrast ratio: 100000: 1 or above
 - (viii) Warranty: The LED T.Vs should have minimum one year warranty from the date of installation
 - (ix) Brand: Reputed Brand like Sony or Samsung
 - (x) Who can offer: Manufacturers of above brands or their authorized distributors/ dealers.
3. Financial offers/quotations shall be submitted in the format enclosed. Break up of applicable taxes may please be given separately. The price quoted should remain valid for a period of 120 days from the last date for submission of the quotation.

4. **Bid Security:** Firms submitting offers/quotations are required to submit an amount of **Rs. 30,000** (Rupees Thirty Thousand Only) through Demand Draft drawn in favour of Bureau of Indian Standards, payable at New Delhi towards bid security (EMD).

7. Please submit a copy of Authorized dealer certificate issued by your principal.
8. All queries related to the tender may be sent in writing to Head, IT Services Department, at the address given above before the last date. Clarifications may also be sought over telephone/email/fax. The last date for submission of Bids mentioned above will remain the same irrespective of the clarifications sought by the Bidders.
9. BIS has right to reject any bid if it is not complete in any respect or if the bidder specifies any requirement which is not matching the requirement(s) specified in the tender document and BIS also reserves the right to reject any or all bids without assigning any reason whatsoever.
10. The Bid Security amount will be forfeited if the bidder withdraws, alters, fails or refuses to accept the assignment during the validity period of the bid.
11. **Performance Security Deposit:** The contractor will be required to deposit a sum equivalent to 10% of the quoted total cost of LED T.V's towards performance security deposit in the form of Demand Draft in favour of Bureau of Indian Standards, payable at New Delhi. The performance security deposit will be retained by BIS for a period of one year i.e. from the date installation/commissioning of LED T.Vs. No interest will be payable by BIS, on this amount. The amount will be refunded after deducting of penalty/dues, if any, after 18 months of installation.
