Sealed quotations are invited for the above mentioned subject, as per the terms and conditions mentioned here under:

- 2. Quotation in sealed cover super scribing "Quotation for tested samples/remnants/scraps" should reach the office at the above address latest by 1300 hrs on 14 October 2014 which shall be dropped in Tender Box kept in ground floor in front of Security. The rate should be quoted taking into consideration the reserve price mentioned in each item separately on weight item basis as listed in <u>Annexure-A.</u> The items are lying in the scrap yard at the basement of the ERTC.
- 3. The quotation must be accompanied with a **Demand Draft for Rs.5000/- drawn** in favour of "Bureau of Indian Standards payable at Kolkata" as Earnest Money. Quotation without Earnest Money shall be summarily rejected. Earnest Money shall be refunded in the event of non-acceptance of the quotation. No interest will be paid on Earnest Money. Please note that Payment of Earnest Money by Cheque will not be entertained.
- 3. The bidder participating in the tender may be preferably Registered Scrap Dealers who shall furnish documentary proof on the subject along with the quotation.
- 4. The entire lot of tested samples/remnants/scraps shall be sold by BIS on "AS IS WHERE IS BASIS". The material as mentioned in the list may be inspected at the premises of ERTC at the above address between 1100h-1500h on Monday, Wednesday and Friday during the period.
- 5. Quotation received shall be opened at **1530h on 14 October 2014** in the presence of such bidders or his authorized representative who may desire to be present at the time of opening quotations.

- 6. The successful bidders shall have to take delivery of the material within 15 days from the date of issue of order from this office, after proper weighment and depositing full amount either in cash or in Demand Draft drawn in favour of this Bureau of Indian Standards payable at Kolkata failing which earnest money deposited will be forfeited. Weighing of the material shall be done in the presence of BIS officials.
- 7. In the process of removing the material from our stores/disposal scrap yard, the bidders will be responsible for the loss/damage of any property of the Bureau due to negligence on his part or on the part of his representative and the amount of loss be recovered from the bidders.
- 8. Duties/taxes wherever applicable/levied by the Central/State/local bodied shall be borne by the bidder and the amount quoted in the offer for various items shall be payable to the Bureau.
- 10. Charges for weighing, packing etc of the material shall be borne by the bidder.
- 11. Quotation shall remain open for acceptance for a period of 60 days from the date of opening of the quotation.
- 12. The Bureau of Indian Standards, Kolkata reserves the right to accepting/rejecting full or part of the quotation(s) or portion of the quantity offered, without assigning any reasons whatsoever.
- 13. The Bureau of Indian Standards, Kolkata reserves the right to reject any or all the quotation(s), if situation so warrants without assigning any reason whatsoever.
- 14. The Bureau of Indian Standards, Kolkata reserves the right to take decision to sell tested samples/the scraps as individual item basis or as a complete lot.
- 15. The Bureau of Indian Standards, Kolkata shall not be responsible for any delay, loss or non-receipt of quotation from the bidder.
- 16. In case of non-compliance with the order within stipulated time on account of any reason the Bureau of Indian Standards, Kolkata reserves the right to:
 - (i) Cancel/rescind/revoke the order.
 - (ii)To forfeit the Earnest Money deposited.
- 17. In case of any dispute, the decision of the Competent Authority of this Bureau shall be final.
