2. All quotation(s) shall remain open for acceptance for a period of 60 days from the date of opening of quotation(s) specified in para 2 above.
3. The rates quoted shall include all charges, such as packing and forwarding, freight, insurance, octroi, etc.
4. The premises mentioned in subject above may be inspected on any working day between 1030 h to 1600 h.

5. All goods shall be received, subject to approval on inspection. The decision of our inspecting officer shall be binding. Rejected items/goods/stores shall be removed by the supplier at his own cost and risk, within 30 days of receipt of notice for the removal of such goods and no liability, whatsoever, on the Bureau shall be attached for the rejected /disapproved goods/items/stores.
6. The Bureau reserved the right to accept or reject summarily any or all quotation(s) in whole or in part without assigning any reason whatsoever
7. The Bureau reserves the right to accept or reject summarily any or all quotation(s) after dispatch.
