<u>CHAPTER - 1</u>: <u>Instructions to Bidders</u>

- 1. Technical Bid of Tender Document: Each page shall be duly signed by the tenderer as a token of their acceptance of the Technical and Contractual details, including tender form duly filled in, complete details and description, including all data to be supplied by the tenderer as specified in the information and instructions to the tenderers. The Envelope No. 1 shall also contain Earnest Money Deposit in the form of crossed Demand Draft of Rs. 10 000.00 in favour of Bureau of Indian Standards, payable at New Delhi/Noida and forwarding letter of the contractor.
- 2. The Tenderer/Bidder shall have at least 3 years experience in this field and shall submit the self attested copies of the following documents along with the Technical Bid:
 - a) Details of works of similar nature carried out in Central or State Govt. Bodies/Departments, Public Sector Undertakings, in the last 3 years ending on 31 March 2006.
 - b) Number of each type of vehicle of Model 2003 (or later) available with their registered No.
 - c) List of any Govt/Public Sector Orgn. to whom you are providing such services. If provided, a copy of letter from such orgn. indicating their satisfaction level with their services.
- 3. The vehicles to be provided to NITS shall be of model 2003 or afterwards.
- 4. The vehicles to be provided shall be kept in perfect running conditions with covers and curtains neat and clean.
- 5. The drivers to be provided by the successful tenderer/bidder (Contractor) shall have minimum 3 years experience with valid driving license and shall be disciplined, polite and courteous.
- 6. General Terms and Conditions of the Contract (enclosed) shall be fulfilled by the Tenderer/Bidder.
- 7. Nature and Scope of Work to be done at NITS is enclosed.
- 8. Tenderer will have to return all the documents issued to them while submitting their tender duly stamped and signed as per General Terms and Conditions enclosed.

CHAPTER -2: General conditions of Contract

- 1. The Earnest Money deposited by the successful tenderer shall be retained and it will be adjusted against the performance security deposit. Performance security deposit shall be 5% of the annual payment and shall have to be deposited immediately after award of work by the successful bidder.
- 2. No interest shall be paid on performance security or earnest money.
- 3. NITS reserve the right thereto without assigning any reason:
 - a. Accept or reject any or all tenders in whole or in part;
 - b. Increase or decrease the quantities of any item of the work and the successful tenderer shall perform the same at the rates quoted.

4. Time period of contract will be for two years from the date of award of empanelment contract.

- 5. TDS and any other taxes as applicable from time to time shall be recovered by NITS from the bills submitted by the contractor. Any change in the rate of TDS shall be to the contractor's account.
- 6. If the services rendered by the contractors or performance of the persons deputed by the contractor is not found to be satisfactory by NITS, the NITS reserves the right to terminate the contract by giving 15 days notice without assigning any reason.
- 7. Successful bidder will be required to submit the Letter of Acceptance within a period of 15 days of receipt by him of notification of empanelment. The Letter of Acceptance will be deemed as binding Contract between Contractor and NITS in respect of all terms and conditions contains in this tender document.
- 8. Sealed tender shall be delivered in person as specified above and tenders sent by registered post shall not be accepted.
- 9. The rates shall be quoted for all vehicles from garage to garage.
- 10. Distance from garage to BIS HQ, 9 BSZ Marg, New Delhi as well as from garage to NITS, Noida shall be indicated.
- 11. The drivers of the vehicles provided must follow traffic rules and other regulations prescribed by the Govt. from time to time.

- 12. Dedicated vehicles and drivers must be provided and changes shall only be allowed in exceptional circumstances. The vehicles shall be available at any time on any day as desired by the NITS.
- 13. The rates shall be inclusive of the charges of driver, repairs and maintenance of vehicle, petrol/diesel, all taxes like toll tax, chungi etc. and also any other incidental expenses. However, service tax, as applicable will be paid extra by NITS.
- 14. Escalation in the cost of operation due to hike in petrol/diesel rates or the cost value of the vehicle or the taxi fares shall be absorbed by the successful bidder.
- 15. Parking charges, on actual basis, will be paid by NITS.
- 16. A daily record indicating time and mileage for each vehicle shall be mentioned which shall be countersigned by NITS authorities.
- 17. Successful tenderers/bidders shall be required to sign the contract/agreement within 15 days of receipt of notification of award of work by him.
- 18. If the empanelled Contractor fails to provide required number of qualified vehicles, the tenderer/bidder (Contractor) shall be liable to pay penalty to NITS at double the notified rates in force for the category of vehicles concerned.
- 19. The successful tenderer/bidder (Contractor) shall submit the bill every month.
- 20. In case of any accident, all the claims arising out of it shall be met by the Contractor.
- 21. If the vehicle is out of order, a substitute vehicle shall be provided by the Contractor immediately. In case vehicle does not report in time or does not report at all, NITS shall have a right to hire a vehicle from the market and the additional cost incurred by NITS shall be borne by the Contractor.
- 22. Any claim arising on account of damage, compensation or expenses payable in consequences of any accident or injury sustained by workman of Contractor or any other person, whether in the employment of the Contractor or not; while in or upon the said works or site of the same, the NITS shall not be bound to entertain any claim or such claim brought under the Workman's Compensation Act.
- 23. The drivers shall not misbehave with any of NITS staff members and shall not enter into any unlawful activities in the premises.
- 24. The successful tenderer/bidder (Contractor) shall be responsible for all other LABOUR LAWS as applicable and also shall be responsible for their compliance.
- 25. TDS and any other taxes as applicable from time to time shall be recovered by NITS from the bills submitted by the successful tenderer/bidder (Contractor). Any change in the rate of TDS shall be to the successful tenderer/bidder (Contractor)'s account.
- 26. The Contractor and drivers provided shall be bound to carry out the instructions of NITS.

27. In the event of any dispute (s), the decision of the Head of Training Instt., Bureau of Indian Standard shall be final and binding.

CHAPTER – 4: Nature & Scope of Work

- ➤ NITS intends to empanel 2 to 3 Contractors for providing the transport services on daily basis.
- ➤ All the types of vehicle listed in Chapter 3 may be hired depending upon requirements.
- ➤ The vehicles may be utilized within NCR or for out-station visits.
- ➤ On an average 2-3 cars may be hired in a day, estimated based on past usage.
- There is however no guarantee whatsoever of minimum services.
- ➤ On average buses may be hired on 20-25 occasions in a year including outstation visits to Agra. However, there is no minimum guarantee.
- ➤ Provided the quality of services and vehicles remains satisfactory, the utilization of services shall be equitably divided among empanelled contractors. However, NITS management shall reserve the sole right to choose to award the work to any one or two contractors on the basis of quality of services and the remaining contractors shall not be entitled to make any claim or representation in this regard.
