2. Technical Requirements:

- **2.1 Chamber**: 8 chamber ageing oven having double walled chambers stuffed with suitable insulating material like Mineral Wool/Glass Wool. The 8 inside chambers shall be circular in size and shall of thick aluminium sheet having size 100 mm diameter X 300 mm height. The insulation provided shall be such that the outside surface at any place shall not have temperature of more than $40 45^{\circ}$ C.
- **2.2 Heaters**: Jacket type electric heaters shall be provided surrounding the chambers to have uniform heating at all places of the chambers.
- **2.3 Temperature Measuring, Indicating & Controlling Device**: Digital temperature indicator cum-controllers with appropriate sensors for individual chambers shall be provided. Temperature range required for each chamber is ambient to 250° C \pm 2° C or better. Additionally suitable thermometer having temp range upto 200° C with least count of 1° C shall also be supplied.
- **2.4 Air circulation**: The air shall enter the chambers of the ageing ovens in such a way that it flows over the surface of test pieces and leaves near the top of the chambers. The ovens shall have a rate of flow of air such that it ensures **8 to 20 air changes per hour** (volume of air required per chamber is **315 to 790 cc per hour**) at specified ageing temperature. The equipment shall be fitted with air flow meter-cum- controllers to control the volume of air passing through the chambers. An air inlet nozzle for airline/air compressor shall be made/provided in the equipment.
