विलंब विवरण

भारतीय मानक ब्यूरो अधिनियम, 2016 की धारा-23 में यह निर्धारित किया गया है कि केन्द्रीय सरकार वार्षिक रिपोर्ट प्राप्त होते ही संसद के प्रत्येक सदन के समक्ष यथाशीघ्र प्रस्तुत करवाएगी।

- भारतीय मानक ब्यूरो नियम, 2018 के नियम 45 में यह विनिर्दिष्ट किया गया है ब्यूरो अपनी वार्षिक रिपोर्ट तैयार करेगा और संसद के प्रत्येक सदन के समक्ष प्रसुतुत करने हेतु वित्तीय वर्ष के नौ माह के भीतर केन्द्रीय सरकार को अग्रेषित करेगा। तदनुसार, भारतीय मानक ब्यूरो अधिनियम और उसके अधीन बनाए गये नियमों के प्रावधानों के अनुसार, भारतीय मानक ब्यूरो को अपनी वार्षिक रिपोर्ट केन्द्रीय सरकार को संसद के प्रत्येक सदन में प्रस्त्त करने के लिए प्रत्येक वर्ष 31 दिसंबर तक सौंपनी अपेक्षित है।
- तथापि, वर्ष 2018-2019 की वार्षिक रिपोर्ट दिनांक 31 दिसंबर, 2019 तक केन्द्रीय सरकार को प्रस्तुत नहीं की जा सकी। वार्षिक रिपोर्ट को अंतिम रूप देने और केन्द्रीय सरकार को इसे प्रस्तुत करने का कालक्रम निम्नानुसार है:-

- (iv) भारतीय मानक ब्यूरो द्वारा उत्तर दिए जाने हेतु नियंत्रक एवं महालेखा परीक्षक से लेखा परीक्षा रिपोर्ट का मसौदा भारतीय मानक ब्यूरो को दिनांक 18.11.2019 को प्राप्त हुआ;
- (v) भारतीय मानक ब्यूरो ने दिनांक 22.11.2019 को नियंत्रक एवं महालेखा परीक्षक को लेखा परीक्षा रिपोर्ट के मसौदा के उत्तर प्रस्तुत किये;
- (vi) माननीय उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री और भारतीय मानक ब्यूरो के शासी परिषद के अध्यक्ष के अनुमोदन की सूचना दिनांक 12.12.2019 को दी गई थी।
- (vii) लेखापरीक्षा कार्यालय से दिनांक 09.01.2020 को अंतिम पृथक लेखा परीक्षा रिपोर्ट (एसएआर) 2018-19 प्राप्त हुई।
- (viii) भारतीय मानक ब्यूरो ने अंतिम वार्षिक रिपोर्ट संसद के दोनों सदनों में प्रस्तुत करने हेतु दिनांक 29.01.2020 को केन्द्रीय सरकार को सौंप दी।
- 4. अत:, नियंत्रक एवं महालेखा परीक्षक से अंतिम लेखा परीक्षा रिपोर्ट की प्राप्ति में हुई देरी, भारतीय मानक ब्यूरो की वार्षिक रिपोर्ट को संसद के दोनों सदनों में प्रस्तुत करने में हुए विलंब का मुख्य कारण है।

DELAY STATEMENT

Section 23 of the Bureau of Indian Standards Act, 2016 lays down that the Central Government shall cause the Annual Report to be laid, as soon as may be, after it is received, before each House of Parliament.

- 2. Rule 45 of the Bureau of Indian Standards Rules, 2018 stipulates that the Bureau shall prepare its Annual Report and forward it to the Central Government within nine months of the end of the financial year for being laid before each House of Parliament. Accordingly, as per the provisions in the BIS Act and rules framed thereunder, Bureau is required to submit its Annual Report to the Central Government by 31st December each year for laying before each House of Parliament.
- 3. However, Annual Report for the year 2018-19 could not be submitted to the Central Government by 31st December, 2019. The chronology of finalization of Annual Report and its submission to the Central Government is as under:-
 - (i) Bureau of Indian Standards (BIS) submitted its Annual Accounts to Controller and Auditor General of India (CAG) on 27th June, 2019;
 - (ii) The Audit of Accounts of BIS for the year 2018-19 completed by CAG on 13.09.2019;
 - (iii) Draft Annual Report for 2018-19 was sent by BIS to this Department on 06.11.2019.

- (iv) The Draft Audit Report was received from CAG by BIS on 18.11.2019 for giving replies;
- (v) BIS submitted its replies to the Draft Audit Report to CAG on 22.11.2019
- (vi) The approval of the Hon'ble Minister for Consumer Affairs, Food and Public Distribution and President of the Governing Council of BIS was conveyed on 12.12.2019.
- (vii) The final Separate Audit Report (SAR) 2018-19 was received from the office of Audit on 09.01.2020.
- (viii) BIS submitted the final Annual Report to the Central Government on 29.01.2020 for laying in both the Houses of Parliament.
- 4. Hence, the delay in laying the Annual Report of BIS in both the Houses of Parliament is mainly due to delay in receipt of final Audit Report from CAG.
