This has reference to the certification of Plugs and Socket Outlets as per IS 1293, which has recently been brought under mandatory certification by DPIIT. IS 1293: 2005 and

It has been brought to our notice that the Licensees who have changed over to 2019 version from 2005 version of IS 1293 are facing problems as the revised scope as per 2019 version does not cover varieties which are still in use in the market, neither is there a suitable alternative in the new Standard.

IS 1293: 2019 are also under concurrent running up to 23 October 2021.

ETD is in process of considering more varieties to be covered under the 2019 version. However, till such time, the deletion of previously covered varieties may cause deterrence to the industry.

In view of such representations, it has been decided that for Licensees who have switched over from IS 1293: 2005 to IS 1293: 2019 and intend to mark certain varieties which are not covered in IS 1293: 2019 but were only covered in IS 1293: 2005, they may do so provided such varieties were already covered in his scope of Licence as per IS 1293: 2005. Licensee shall give an undertaking that such marking will be ceased when IS 1293: 2005 is withdrawn.

It shall also be mentioned explicitly in the Scope of Licence/ Endorsement that the scope as per 2005 version shall be valid only till IS 1293: 2005 is in force. BOs may ensure that the varieties which are being permitted to be marked as per IS 1293: 2005 are deleted once IS 1293: 2005 is withdrawn.

This issues with the approval of CA.
