





Automation of Renewal of Licence under Conformity Assessment Scheme-I of Schedule-II of the BIS (Conformity Assessment) Regulations, 2018

- i) The process for renewal of licence has been automated in Manakonline and any operative licence will be automatically processed for renewal on receipt of the application for renewal of licence in the stipulated form along with the fee.
- ii) The endorsement for renewal of licence will also be automatically generated by the system for the renewed licences.
- iii) The necessary undertaking(s) in this regard are also being in-built into the system for acceptance by the licensee which is reproduced below:
 - a) *“ If any additional amount is found to be payable by the undersigned due to change in unit rates or revision of Minimum Marking Fee during the validity period of the license, I hereby undertake to deposit the required amount as conveyed by the Bureau, within seven days of receipt of communication by the Bureau. In case of failure to deposit the required amount within the stipulated time frame, the license shall be liable to be suspended unless the Bureau has extended the deadline of submission of the dues. ”*
 - b) *“ In case the licensee has paid the renewal fee in excess of the due amount the Bureau shall refund the excess amount paid or adjust the same against the subsequent renewal fee due from the licensee. ”*

Subsequent Action by BIS after Auto-Renewal

- i) All the cases where licences are automatically renewed shall be verified by the BOs for its completeness.
- ii) Any shortfall in terms of documents and fees shall be ascertained and communicated to licensee within **seven working days** of automatic renewal.
- iii) The licensee shall be advised to comply with the directions issued by the Bureau in this regard and submit shortfall documents/fees, if any, within **seven days**.
- iv) In cases where excess fee is paid by the licensee, the same shall be processed for refund or adjustment during subsequent renewal.
- v) Any non-compliance on part of licensee shall be treated as violation of Regulation 10(2)/ Regulation 6 (10) of the BIS (Conformity Assessment) Regulations, 2018, as the case may be and cases shall be processed for suspension/cancellation accordingly, as per the prevailing guidelines.

Renewal Of Licence

- The applications for renewal of license which are received (complete in all aspects) prior to 7 working days of validity of license will be processed for renewal before the validity date of licence.
- Production statement(s) of the licensee shall be obtained on the letter head of the chartered accountant/cost accountant (CA) indicating its membership number along with name of the unit, address and actual quantity produced for the said period.

Special Provision on Renewal Of Licence

- If a manufacturer holding a license, which is due for renewal, submits an application at least a month before the validity date, **requesting for the expiry of his license to be kept in deferment (abeyance)** for a period not exceeding a year from that date, for his inability to operate the license because of financial problems arising out of lack of demand for the ISI-marked product, the request will be accepted, and the expiry of the license will be kept in abeyance(deferment) for a specified period not exceeding one year from the date on which it became due for renewal, subject to an undertaking that he must not use ISI mark on the product manufactured during this period and the deposit of 10% of the Minimum marking Fee or Rs 7000/- (whichever is higher) as the cost of surprise surveillance. Such licenses shall be categorized as **Dormant Licenses** and the BIS Care, the mobile app for complaint management, shall show the status of the license as Dormant.
- The license-holder, the expiry of whose license has been kept in abeyance, can apply for the renewal of the license any time within the specified period, following the terms and conditions for renewal, and the same shall be allowed, and the amount of 10% of the Minimum Marking Fee or Rs 7000/- (whichever is higher) be adjusted against the requisite fee. If he fails to apply for renewal within the specified period, the license shall stand expired from the last date of the specified period.

Special Provision on Grant Of Licence to Manufacturers with Expired Licences

- The manufacturer whose licence has expired for non-submission of application for renewal, failure to pay the renewal fee in time, or surrender of the license voluntarily, if applies for the grant of license **within a year** of the expiry of the license, and **the product applied for is same in all respects, and the test requirements under the standard have not changed**, the application can be considered for grant of license on the basis of factory testing. All the tests possible to be done in a day would be carried out, and sample would be drawn for independent testing. Licence would be granted without waiting for the receipt of test report. Appropriate decision would be taken after the test report is received in line with guidelines for verification sample under simplified procedure (option 2).

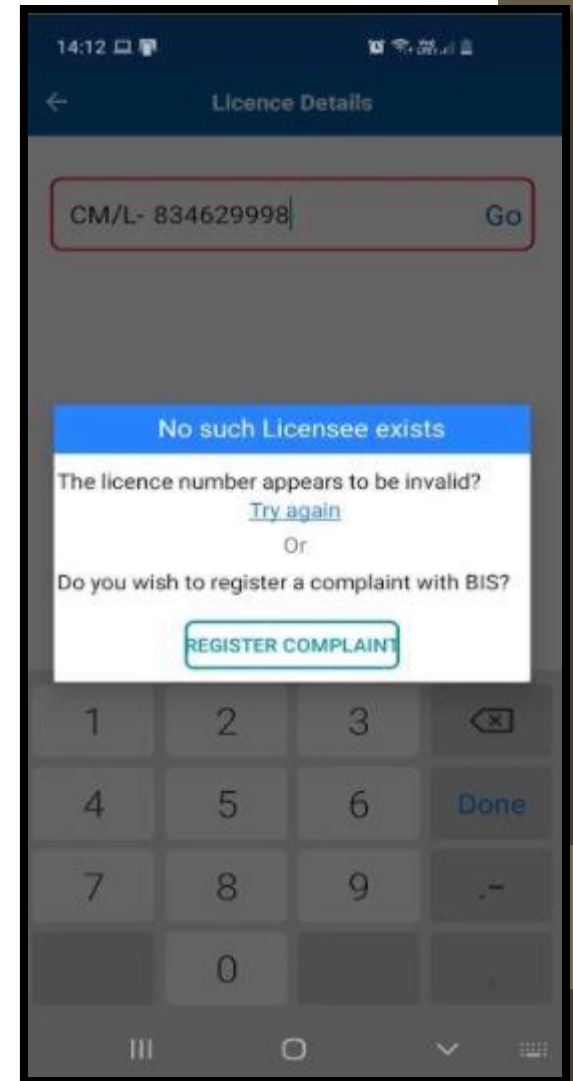
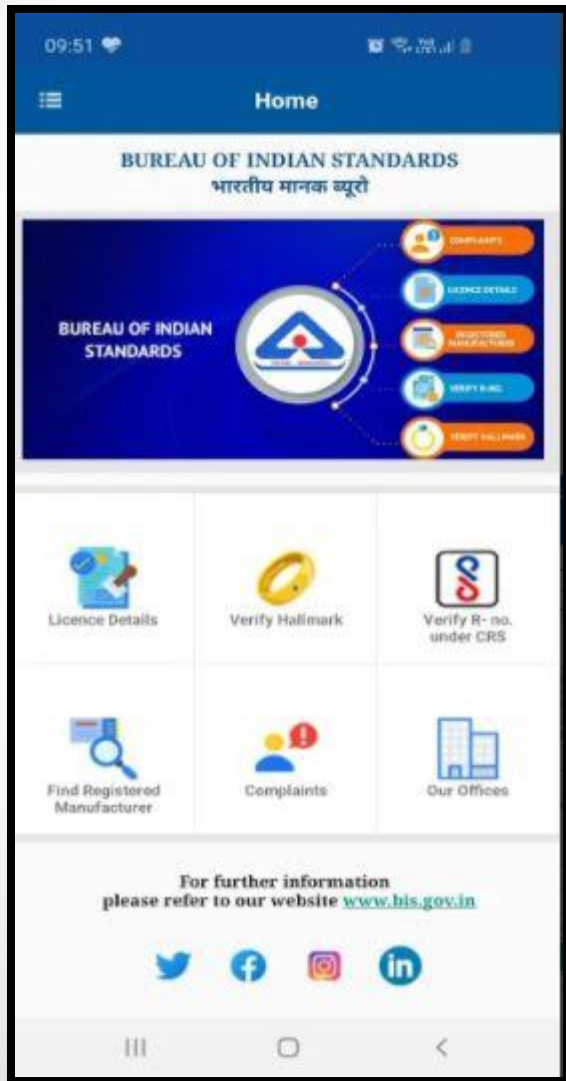
