**विषय: ""उत्पाद प्रमाणन के लिए बी आई एस की अनुरूपता आकलन योजनाओं का मूल्यांकन" के लिए सगठनों की नियुक्ति के लिए रुचि की अभिव्यक्ति (ई ओ आई) - के संबंध में।**

भारतीय मानक ब्यूरो ने उपरोक्त विषय के संबंध में 13-दिसंबर-2021 को रुचि की अभिव्यक्ति जारी की है, जिसे बी आई एस वेबसाइट और केन्द्रीय सार्वजनिक खरीद (सी पी पी) पोर्टल दोनों पर उपलब्ध कराया गया है।

यह सूचित करना है कि 27 दिसंबर 2021 को आयोजित पूर्व-ईओआई के परिणामस्वरूप, ई ओ आई में निम्नलिखित परिवर्तन किए गए हैं

- 1) तथ्य पत्रक के क्रमांक (x) और क्लॉज़ 12 के अनुसार ई ओ आई जमा करने की अंतिम तिथि 4 जनवरी 2022, 1530 बजे से 19 जनवरी 2022, 1530 बजे तक के लिए बढ़ा कर दी गई है।
- 2) 5(1)(जी) के अनुसार, पात्रता मानदंड के लिए साक्ष्य यह आकलन करते हुए कि आवेदक ने पिछले 7 वर्षों के दौरान राष्ट्रीय स्तर पर कम से कम 3 मूल्यांकन या अनुसंधान परियोजनाओं को पूरा किया हो, को "क) कार्य आदेश या अनुबंध दस्तावेज़ की प्रति जिसमें कार्य का दायरा, सुपुर्दगी लागत, समय-सीमा का संकेत मिलता है ख) ग्राहक से पूर्णता प्रमाण पत्र पूरा होने की तारीख का संकेत दिया गया हो ग) मूल्यांकन या शोध अध्ययनों का सारांश" से बदल दिया जाए।
- 3) क्लॉज़ 7 के अनुसार अप्रोच पेपर जमा करने की अधिकतम सीमा 5 A4 आकार के कागज से बढ़ाकर 10 A4 आकार के कागज कर दी गई है।
- 4) Annexure VI, मूल्यांकन मैट्रिक्स को Annexure A के अनुसार संशोधित किया गया है।

Bureau of Indian Standards has floated Expression of Interest in relation to the aforementioned subject on 13-Dec-2021, made available on both BIS website and Central Public Procurement (CPP) Portal.

This is to inform that consequent to Pre-EOI held on 27 Dec 2021, following changes have been made in the EOI

- 1) Last date for submission of EOI as per Sl no (x) of Fact Sheet and Cl 12 has been postponed from 4 Jan 2022 1530 hrs to 19 Jan 2022 1530hrs.
- 2) Evidence for Eligibility Criteria assessing that the applicant should have completed at least 3 evaluation or research projects at national level during last 7 years as per 5(1) (g) may be replaced with “a) Copy of Work Order or Contract Document indicating scope of work, deliverables, cost, timelines b) Completion Certificate from Client indicating date of Completion c) Synopsis of the evaluation or research studies”
- 3) The Maximum limit for submitting the Approach paper as per Cl 7 has been increased from 5 A4 size paper to 10 A4 size paper.
- 4) Annexure VI, the Evaluation Matrix has been revised as per the Annexure A.
