Bureau of Indian Standards, the National Standards Body of India is carrying out various activities to improve quality environment in Indian industry. As a hand holding activity, BIS, Hubli Branch Office (HUBO) is organizing a **Two Day Capsule Training Course for Packaged Drinking Water (IS 14543)** to improve the skills of Quality Control Personnel (Chemist/Microbiologist/Technical Personnel involved in quality control activity). The course will include 1½ day inhouse training and ½ day laboratory visit. Certificates will be provided after successful completion of the training.

The Training Programme will be held **on 27 & 28 June 2022**. - (1) Requirements of relevant Indian Standards (IS 14543 & IS 15410) and Amendments.
- (2) Product Manual, Scheme of Inspection and Testing (SIT), Product specific Guidelines.
- (3) Guidelines for applying for new license, Renewal, and Inclusions.
- (4) Brief elaboration on condition of licence, conformity assessment regulations 2018.
- (5) Testing Parameters/Sample Preparation including conditioning of samples
- (6) Hands on Testing/Practical demonstration of testing of important/critical parameters.

The programme is being conducted at **free of cost and first come first serve** basis. You may nominate one person for the training programme and send the duly filled nomination form (attached). **Last date for receipt of nominations is 23 June 2022** (through email to hubo@bis.gov.in).
