- ☐ In case of certain products/processes/services for which Indian Standards are not available; such gap areas are identified in timely manner and respective technical committees can take up the matter for formulation of standards on such areas.
- ☐ Standards and quality culture is imbibed in central/state government departments across all levels, as adherence to Indian Standards fosters a culture of quality and reliability within government departments.
- ☐ For future schemes/missions government departments can proactively get involved with BIS for providing the necessary assistance pertaining to standardization needs related to upcoming schemes/missions.
- ☐ This will assist Ministries in preparing Annual Work Programme for Standardization.

The Indian Standards for each scheme mission have been classified into two broad categories:

- ☐ Product Standards
- ☐ Other than Product Standards

For each of these broad categories we have further identified:

- ☐ Standards Available
- ☐ Standards Under Development
- ☐ Areas Identified for Standardization in Future

Furthermore, mandatory standards under Quality Control Order (QCO) have been marked in dark shades.

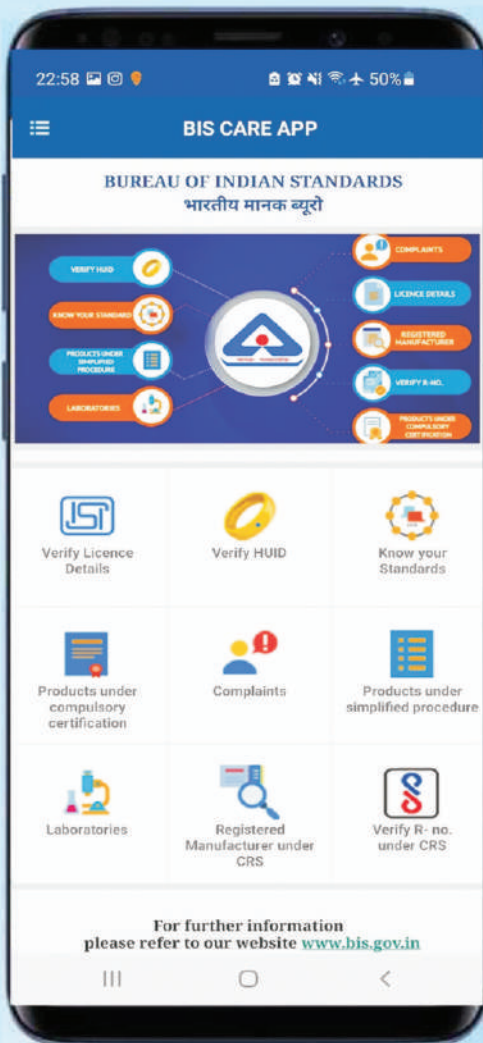
