 - ii) त्रुटि(त्रुटियों) का सुधार नाम, जन्म का वर्ष, या लिंग में;
 - iii) 01.07.2024 से CGHS Beneficiary ID को ABHA Number से जोड़ने।

It is circulated for information of all concerned that an Office Memorandum F.No. Z15025/23/2023/DIR/CGHS(Comp No. 8236195) I/3663776/2024 dated 28 March 2024 and subsequent OM dated 15 April 2024 has been issued by the Directorate, CGHS, Ministry of Health & Family Welfare, on the above mentioned subject. A copy each of the CGHS Office Memorandum's are also attached herewith.

2. As per the Office Memorandum:

- a) It has been decided that linking of CGHS Beneficiary ID with the Ayushman Bharat Health Account (ABHA) ID shall be mandatory w.e.f. 01 April 2024 and vide OM dated 15 April 2024, creation of ABHA ID (ABHA Number) has been extended for a time period of 90 days, w.e.f. 30.06.2024 (3 months from 30.06.2024).
- b) Linking of ABHA number with CGHS card has been extended for a time period of 120 days, w.e.f. 30.06.2024 (4 months from 30.06.2024).
- c) In order to assist the CGHS beneficiaries, KIOSKS shall be made operational at all the wellness centres by 30.06.2024.
- d) The beneficiaries may visit their nearest CGHS wellness centre on need basis for availing assistance in respect of:
 - i) Updating their mobile number
 - ii) Correction of error(s) in name, year of birth, or gender
 - iii) Linking of CGHS beneficiary ID to ABHA number; from 01.07.2024 onwards.
- 3. The process "How to link CGHS ID to ABHA ID" is also attached with this Circular.

4. Therefore, all the concerned BIS CGHS beneficiaries (employees/pensioners) are advised to Link CGHS Beneficiary IDs with Ayushman Bharat Health Account ID (ABHA).

1. Go to the official website of https://cghs.nic.in

2. Click on the 'Beneficiaries' options in the menu.

3. Select 'Beneficiary Login' and enter your beneficiary ID, password, and captcha. In case, the password is not known, the user can generate or reset the password.

4. An OTP will be sent to the registered mobile number.

5. Upon completing this process, to create a link and create your ABHA ID, go to the Update menu and click on Create/Link Abha ID.

6. Click on 'I don't have ABHA number'

7. Next, enter your Aadhaar number

8. Read all the terms and conditions and give consent.

8. Enter the OTP and verify it.

9. Following this, users can check the link status. If the details are matched, one can get a printout.

10. Once the ABHA ID is obtained, enter the same in the link using a number in the Consent Collection.

11. Enter the OTP received on the registered number and verify it.

12. Next, one will be able to see the status of the CGHS beneficiary ID and ABHA ID. If the details match, a printout can be taken.
