## Guidelines for filling up the application form

- 1) Name, address of the firm's headquarters (Office) (The address at which WMI code is being applied for) and location of the plant (manufacturing unit) to be filled up in the application.
- 2) The application and all the pages of the attached documents are to be signed by one of the Directors/ Partners/ Proprietor/ Authorized signatory (If the application is being signed by any person other than the Director/Partner /Proprietor, then an Authorization letter from any of the above authorising a signatory shall be attached) as the case may be.
- 3) It may be ensured that all the pages of the documents submitted as part of the application are sealed and signed by Directors/ Partners/ proprietor/ Authorized signatory as the case may be.
- 4) Self-certified copy of Certificate of Incorporation along with Memorandum of Association and Articles of Association/ Partnership deed, as the case may be, to be attached. Please note that the address given in Certificate of Incorporation / Partnership deed shall match with the address of the Headquarters (office) mentioned in the application form.
- 5) Self-certified copy of the Udyam Registration certificate issued by MSME or Industrial Entrepreneurs Memorandum( IEM) from Department for Promotion of Industry and Internal Trade (DPIIT), Gol allowing firm to carry out the manufacturing of automobile and specifying the product codes and categories is to be attached. The address of Headquarters and manufacturing facility mentioned in these documents should match with the address of headquarters and manufacturing facility/facilities respectively mentioned in the application form. Please note that the products for which WMI code is being applied for may either be a part of the range of products or complete range of products, that the manufacturer is permitted to manufacture as per Udyam Registration Certificate/IEM from DPIIT. WMI code will not be given for any products which do not belong to the range/categories of products mentioned in the Udyam Registration Certificate/IEM from DPIIT submitted by the applicant.
- 6) Payment of Rs.5000/- + Applicable GST in favor of Bureau of Indian Standards through Demand Draft payable at New Delhi towards the processing charges for allotment of WMI code. Applicant is advised to furnish their GSTIN and other relevant information for issuing appropriate Receipt-cum-Tax Invoice.
- Self-certified copy of the photo ID (Such as Aadhar Card/Driving Licence/Voter ID/Passport etc or any other photo ID issued by Government of India) of the person signing the application and any other relevant documents.
