# 2. Article Published on the Occasion of National Consumers Day 2024

As part of the National Consumers Day celebrations, impactful jingles were aired on Radio City Live, enhancing public awareness about consumer rights and safety.



# **6. Sensitization Programme on National Consumer Rights Day in Association with Consumer Group**

On 24th December 2024, a sensitization programme was organized in association with Tamil Nadu Progressive Consumer Centre. The session covered key BIS activities, including standardization, conformity assessment, laboratory activities, and hallmarking of gold and silver jewelry. The participants were sensitized about BIS's role in nation-building and consumer protection. As part of the programme, the **BIS Care App** was demonstrated and downloaded on participants' smartphones, highlighting its critical features for consumer protection and information. The programme successfully raised awareness among students about the vital role of BIS in safeguarding consumer interests.









#### 7. Competitions in BIS Standards Clubs

As part of the campaign to promote the use of BIS-certified products, including hallmark-certified jewelry, ISI & CRS marked products, and Quality Control Orders (QCOs), BIS Standards Clubs organized a series of awareness competitions. These competitions included poster contests, standards writing competitions, and skit/elocution events aimed at engaging and educating participants.

Some institutions have planned to hold these competitions before 10th January 2025 due to vacation leaves, ensuring continued awareness and participation in the campaign.













#### 8. BIS Stall at Soumex 2024 International Exhibition

A dedicated BIS stall has been set up at Soumex 2024 to raise awareness about Indian Standards and engage with a wider audience. The Chennai Branch Office (CNBO) is participating in the "Sourcing & Manufacturing Supply Chain" exhibition, organized by the Tamil Nadu Small and Tiny Industries Association (TANSTIA), which will be held on 27th, 28th, and 29th December 2024.

The exhibition is expected to attract around 20,000 participants, with 38 district industry associations attending the event. The BIS stall will serve as a platform to educate the public on the importance of quality standards and BIS certification.
