Open call for Empanelment of experts in the area of safety audits for Machinery and Electrical Equipments

Rolling advertisement inviting applications for 'Empanelment of experts (individuals) to assist for safety of machinery and electrical equipment audits' on behalf of the Bureau

- The Bureau of Indian Standards (BIS), also known as the Bureau, is the national Standards Body of India working under the Department of Consumer Affairs, the Government of India. Established in 1947, the organisation's position has been further strengthened as an essential stakeholder in the Indian economy through the enactment of the BIS Act by the Parliament of India. The Bureau is engaged in the activities of standards formulation and conformity assessment activities like certification and testing in order to ensure quality and safety of products available in the National market. The Bureau has been providing tangible benefits to the country's economy in a number of ways enabling safe, reliable and quality goods; minimising health hazards for the public; promoting healthy trade; control over proliferation of sub-standard goods through standardisation and conformity assessment activities.
- 2) BIS undertakes conformity assessment activities and grants certification to manufacturers as per Rules and Regulations framed under the BIS Act, 2016. The conformity assessment activities involve review of submitted documentation, assessment of product compliance as per technical criteria laid down in Standards. The Ministry of Heavy Industries, Government of India has notified Machinery and Electrical Equipment Safety (Omnibus Technical Regulation) Order, 2024 mandating compliance to Standards and compulsory certification from BIS. For certification in

this sector, both desk-audit and product compliance audit at the site are required to be

undertaken for which assistance of individual experts of Indian citizenship is expressed

through this open call from motivated individual experts having requisite and relevant

industry experience.

3) BIS seeks application for empanelment through this open call and rolling advertisement

which shall remain open without any last date of submission of application by

interested and eligible experts.

Annexure-I

(Ref No: CMD-I/6:10/20250819/01/Annex-1) Guidelines and terms of reference for empanelment of experts

Details of scope of work, educational qualification and experience criteria required for experts, norms for admissible payment rates, deployment and other conditions

- Introduction Notified by the Ministry of Heavy Industries, the Government of India on 22 August 2024, the Omnibus Technical Regulation (OTR) covering more than 440 products aims to assure safety of machinery and electrical equipments through certification by BIS. BIS is engaged in the product certification as per various conformity assessment schemes notified under the BIS (Conformity Assessment) Regulations 2018. For this OTR regulation, Scheme-X of BIS has been prescribed for conformity assessment procedure which would involve audit of technical file(s).
- **Scope of work** The assistance required from individual empanelled experts includes audits to verify compliance of machinery and electrical equipments certification cases under Scheme-X received at BIS by way of:
 - 2.1 Desk audit for examination of technical file(s) submitted by the manufacturer situated within India
 - 2.2 Product compliance audit at the site within India alongwith BIS officer(s) and/or other empanelled expert(s)
 - 2.3 Submission of audit reports to BIS for the allocated works undertaken
- 3 Eligibility criteria Experts to be assigned work by BIS shall normally be of age upto 60 years and shall in any case be less than 70 years of age. Empanelled experts allocated work must be citizen of India and should meet the following eligibility criteria
 - 3.1 **by education** atleast B.Tech/B.Engineering (or equivalent) in one of disciplines
 - 3.1.1 Electrical or
 - 3.1.2 Electronics or
 - 3.1.3 Mechanical or
 - 3.1.4 Automation or
 - 3.1.5 Instrumentation

- 3.2 **by industrial experience** atleast 5 years (non-IT industry) familiar with handling machines in functions like
 - 3.2.1 Manufacturing or
 - 3.2.2 Maintenance or
 - 3.2.3 Design or
 - 3.2.4 Production
- 3.3 **by audit related relevant experience** atleast 2 years in risk assessment of machines as per IS 16189/ISO 12100 in functions of
 - 3.3.1 Providing solutions to make a machine safe and
 - 3.3.2 Done at least risk assessment of 5 machines in last 2 years and
 - 3.3.3 Basic understanding of safety control system on a machine as per IS 16810 (Part 1)/ISO 13849-1 for various categories and performance levels and
 - 3.3.4 Proficient in use of IT devices and tools for reporting to BIS
- **Application submission**: The applications are required to be emailed to cmd1@bis.gov.in and also submitted in hard copy in a sealed envelope with a covering letter (Form-1) addressed to the Head, Central Marks Department-I of BIS with duly filled other forms (Form-2 and Form-3) given in this document. The signed copy of this open call/rolling advertisement (with Annexure-I) is also required to be signed on each page and submitted. Copies of supporting documents enclosed with the application shall be legible and self-attested. BIS reserves its right to call for verification, originals of all self-attested copies of uploaded documents from the individual before empanelment.
- **Review process for empanelment**: Profiles of candidates who apply for empanelment would be reviewed by BIS. Candidates who fulfill the minimum eligibility criteria as per paragraph 3 of this annexure will be called for interactive discussion with a committee constituted by BIS.
 - 5.1 Interaction is preferably planned to be held in physical mode at the BIS HQ, New Delhi. The applicant shall bear all the expenses including travel, boarding and lodging for this interactive discussion.
 - 5.2 During the interactive discussion, the experts may make a presentation (normally of 10 slides) about the understanding and technical expertise in the

areas covered under OTR regulation which will be assessed as per following scoring criteria:

- 5.3 The competence for technical audit of compliance of machinery and electrical equipment categories (atleast in one category against the listing given in OTR) is required to be demonstrated.
- 5.4 Any additional categories of machinery and electrical equipment covered under OTR regulation (with atleast basic knowledge) where the expert would be willing to work may also be indicated.
- **Remuneration for the works allotted** The remuneration provided by BIS for services provided by the empanelled experts shall be as follows:

- 6.1 For travel and stay accommodation, arrangements as per entitlements of an officer (Level 11) of BIS shall be made by the Branch Offices.
- 6.2 Experts are expected to make arrangements towards IT resources like hardware (laptop/tablet) and internet themselves.

- Orientation and awareness before work assignment: BIS will provide orientation and conduct awareness sessions for the certification processes and procedures involved. These sessions are planned to be held preferably in physical mode at the training institute of BIS situated at Noida. For the same, travel shall be arranged by the experts themselves. The stay and accommodation will be provided by BIS. Such sessions would be conducted after the empanelment and if required may also be conducted afterwards.
 - 7.1 The audit works done by empanelled experts would be observed during the site visits and also during the review of reports submitted. BIS reserves its right to elaborate further on the brief overview and scope of work, machinery/equipment specific additional knowledge criteria and other terms & conditions which shall be informed to empanelled experts.
 - 7.2 Any modifications/alterations may also be done by BIS for overall scope of work and other conditions which shall be duly informed to all empanelled and future prospective applicants. Timely completion of activities is also important for final delivery of certification services to the stakeholders.
- **8 Work assignment**: Deployment of individual empanelled experts will be based on the influx of certification applications received from manufacturers. Empanelment does not confer any legal or contractual rights for allocation of work.
 - 8.1 The expert will be deployed for carrying out the desk audit and product compliance audit at site as per the requirement of certification scope applied by the manufacturer and at the sole discretion of BIS.
 - 8.2 Audit(s) carried out by empanelled experts are required to be reported to BIS in the prescribed format(s) physically or through the online platform operated by BIS, as advised, within 10 days. Penalty from 0.5% to 5% for the payment of each individual case and task may be imposed.
 - **Obligations of the experts**: Strong ethics and integrity are expected from empanelled experts. Experts to be assigned work by BIS shall normally be of age upto 60 years and shall in any case be less than 70 years of age. Experts will be dropped from the empanelment; if quality of work, punctuality, discipline or any concerning behaviour is observed for ethics and integrity aspects.

- 9.1 Information shared by BIS and/or obtained through audit(s) are strictly confidential. Such information shall not be shared with anyone and also shall not be used for any purpose other than the work assigned by BIS.
- 9.2 Any conflict of interest that may arise due to reasons like association of empanelled experts for the audit process is required to be declared during the empanelment process and re-confirmed before taking up any work assignment by BIS.
- 9.3 All the aspects (indicated in Form-3, signed copied to be submitted) and instructions provided by BIS for audit assignment(s) shall be complied.
- 9.4 In case of any dispute that cannot be resolved amicably, the same shall be referred to the sole arbitrator appointed by the Director General, Bureau of Indian Standards, whose decision shall be final and binding. The provisions of the Arbitration and Conciliation Act, 1996, as amended from time to time, shall be applicable.
- 9.5 No suit or other proceedings relating to empanelment, shall be filed in any Court of Law except the competent Courts of Law having jurisdiction within the local limits of New Delhi only, where headquarter of the Bureau is located.
