**प्रयोगशाला इंटरनशिप योजना के तहत इंटरनशिप करने के लिए योग्य उम्मीदवारों से आवेदन के लिये आमंत्रण
Nominations sought from eligible candidates for carrying out internship under the laboratory internship scheme**

1. भारतीय मानक ब्यूरो (बीआईएस) उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्रालय, भारत सरकार के प्रशासनिक नियंत्रण के तहत एक वैधानिक निकाय है। यह भारत का राष्ट्रीय मानक निकाय है, जो देश में मानकों के सामंजस्यपूर्ण विकास, विभिन्न अनुरूपता मूल्यांकन योजनाओं को क्रियान्वित करने, इन योजनाओं के दायरे में उत्पादों के परीक्षण और उससे जुड़े प्रासंगिक मामलों के लिए जिम्मेदार है। Bureau of Indian Standards (BIS), is the national standards body of India. It is a statutory body under the administrative control of Ministry of Consumer Affairs, Food and Public Distribution, Govt. of India. BIS is responsible for harmonious development of standards in the country, executing various conformity assessment schemes, testing of products under the ambit of these schemes and for matters connected therewith or incidental thereto.

2. बीआईएस की उत्पाद प्रमाणन योजना के अंतर्गत आने वाले विभिन्न उत्पादों के परीक्षण के लिए पटना में एक प्रयोगशाला स्थापित की गयी है। पटना शाखा प्रयोगशाला (पीबीएल) में विभिन्न उत्पादों जैसे सीमेंट, स्टील, प्लाईवुड, पैकेज्ड ड्रिंकिंग वॉटर आदि के यांत्रिक, रासायनिक और सूक्ष्मजैविक परीक्षण की सुविधाएं उपलब्ध हैं।

BIS has a laboratory at Patna for testing various products covered under its product certification scheme. Patna Branch Laboratory (PBL) has facilities for mechanical, chemical and microbiological testing of various products e.g., cement, steel, plywood, Packaged Drinking Water, PVC etc.

3. बीआईएस की एक इंटरनशिप योजना है जिसके तहत छात्रों को मानकीकरण और गुणवत्ता के विभिन्न पहलुओं से अवगत कराया जाता है। इससे उन्हें बीआईएस की प्रयोगशाला गतिविधि के बारे में विस्तार से जानने का अवसर मिलेगा जो कॉलेज में उनकी शिक्षा को पूरक बनाएगा। प्रशिक्षुओं को पीबीएल में प्राप्त विभिन्न उत्पादों के परीक्षण के बारे में प्रत्यक्ष ज्ञान प्राप्त होगा। पासआउट हो चुके छात्र भी अपनी पढ़ाई पूरी करने के छह महीने के भीतर आवेदन कर सकते हैं।

BIS has a laboratory internship scheme which introduces students to the various facets of standardization and quality. It gives them an opportunity to learn about the laboratory activity of BIS in detail which will supplement their learning in college. The interns will gain a firsthand knowledge about the testing of various products received at PBL. Pass outs can also apply within six months after completing their studies.

4. इंटरनशिप योजना में भाग लेने के लिए योग्य उम्मीदवारों से आवेदन आमंत्रित किए जा रहे हैं। आवेदन जमा करने के लिए योग्यता मानदंड और प्रासंगिक दस्तावेज हमारी वेबसाइट <https://www.bis.gov.in/wp-content/uploads/2025/1/ANNEXURE.pdf> से डाउनलोड किए जा सकते हैं।

Applications are invited from eligible candidates for participating in the internship scheme. The eligibility criteria and relevant documents for submitting the application may be downloaded from our website <https://www.bis.gov.in/wp-content/uploads/2025/1/ANNEXURE.pdf>.

5. उम्मीदवारों का चयन उनके शैक्षणिक प्रदर्शन के आधार पर किया जाएगा। इंटरनशिप की अवधि अधिमानतः छह महीने की होगी।

The candidates will be selected on the basis of their academic performance. The duration of internship will preferably be for a period of six months.

6. विज्ञान/डिप्लोमा पाठ्यक्रमों में स्नातक की डिग्री हासिल करने वाले प्रशिक्षुओं को 15000.00 रुपये प्रति माह और इंजीनियरिंग/प्रौद्योगिकी में स्नातक या मास्टर डिग्री या उच्चतर डिग्री हासिल करने वाले प्रशिक्षुओं को 20000.00 रुपये प्रति माह का वजीफा प्रदान किया जाएगा। वजीफे की गणना प्रत्येक पूर्ण सप्ताह के लिए आनुपातिक आधार पर की जाएगी। प्रशिक्षुओं के लिये न्यूनतम 95% उपस्थिति की आवश्यकता होगी।

The interns pursuing Bachelor's degree in Science / Diploma Courses will be provided a stipend of Rs. 15000.00 per month and those pursuing Bachelor's degree in Engineering / Technology or Master's degree or higher will be provided a stipend of Rs. 20000.00 per month. The stipend will be calculated on pro-rata basis for each completed week. The interns will also be required to have at least 95% attendance.

7. आवेदन आवश्यक दस्तावेजों के साथ pbol@bis.gov.in पर ईमेल के माध्यम से "Application for internship at PBL, BIS" विषय पंक्ति के साथ सभी दस्तावेज की प्रति Annexure -C के अनुरूप प्रयोगशाला को उपलब्ध करानी अनिवार्य है। अक्टूबर 2025 से इंटरनशिप करने के लिए आवेदन जमा करने की अंतिम तिथि 27 सितम्बर 2025 है।

The application must be submitted along with the requisite documents as per Annexure-C of the advertisement through email at pbol@bis.gov.in with the subject line "Application for internship at PBL, BIS". The last date of submission of applications for carrying out the internship w.e.f. October 2025 is 27 September 2025.

- **Graduates/Diploma holders who have completed their studies within the last 180 days (06 months) are eligible for internship. For considering the eligibility of the applicant, the last date of the term of the university/institution of the applicant and the date of submission of internship application by the applicant will be taken for calculation of 180 days.**

Annexure-B

Terms & Conditions of Internship

- (i)** The Intern, under no circumstances shall claim to become the employee of BIS. Nothing in this Scheme shall create, or be deemed to create, a partnership or the relationship of employer and employee between BIS & the Intern.
- (ii)** The Interns shall be duty-bound to follow the methodology and instructions given by the BIS and adhere to the time-frame for various aspects of their work.
- (iii)** The Interns shall be required to submit the Report for the duration as completed, to the concerned BIS authority failing which s/he would not be issued the Certificate of Internship.
- (iv)** Interns shall not divulge or disclose to any person, any details of BIS office(s), security arrangements, administrative/operational process, any technical know-how, and other organizational matters.
- (v)** Interns shall maintain confidentiality of data and shall not divulge or disclose to any person, any details of the Manufacturer or other organizations collected/ obtained as part of their internship.
- (vi)** Interns shall be liable for costs accrued on account of any loss that might be caused to BIS due to lapse on his/her part while discharging in willful or accidental manner including fraud, etc.
- (vii)** Any violation of instructions or suppression of facts or disclosure of BIS matters, records, documents, Indian Standards, Special Publications etc. in hard or soft form to an outsider shall lead to termination of Internship without any reference.
- (viii)** The BIS shall be within its right to terminate the Internship forthwith or take any other action without assigning any reason whatsoever.
- (ix)** Any or all the terms and conditions can be changed with the approval of Director General, BIS.
