**Subject: Extension in time lines for switchover to 10-digit licence number from Automotive Tyre and Tube industry**

This has reference to the subject mentioned above.

Guidelines for switchover for such licences were issued vide Circular bearing Reference Number CMD-I/2: 10 dated 06 Sep 2024, providing one year time (i.e. up to 06 Sep 2025) for switchover by licensees to mark 10-digit licence number on products/packages etc..

In view of the requests received from Automotive Tyre and Tube industry, the last date for implementation of switchover to 10 digit licence number has been extended by 3 years from 06 September 2025, only for tyres as per IS 15627, IS 15633 and IS 15636 and tubes as per IS 13098. All BOs shall bring it to the notice of all concerned Licensees and Applicants and ensure implementation of switchover for these products by 06 September 2028. During this period, usage of both existing 6/7 digit licence number and 10 digit licence number on the product/package will be permitted.

The other provisions of the Circular bearing Reference Number CMD-I/2: 10 dated 06 Sep 2024 shall remain the same.
