Subject: Extension of the period of concurrent running of IS 2046 : 1995 and IS 2046 (Part 1 to 8): 2025- “Decorative Thermosetting Synthetic Resin Bonded Laminated Sheets”

This has reference to the subject mentioned above.

IS 2046: 1995 (Decorative Thermosetting Synthetic Resin Bonded Laminated Sheets) was revised to IS 2046: 2025 with last date of implementation of the revised ISS as 24th September 2025, which was extended upto 24th MARCH 2026 vide circular number: CMD-2/16: IS 2046 dated 25 September, 2025.

Considering that the revised IS 2046:2025 may not be implementable at present and as the draft amendment to the revised ISS for wide circulation is still under process, the concurrent running of IS 2046: 1995 and IS 2046 (Part 1 to 8): 2025 and the **last date of implementation of IS 2046 (Part 1 to 8): 2025, has now been further extended up to 24th MARCH 2027.**
